Project Description: Barnhart Ranch, the applicant, has proposed to expand its existing egg laying hen ranch operation by constructing three (3) new cage free barns resulting in an increase in capacity of 1,098,000 hens. In addition, Barnhart Ranch will construct a 77,318 square foot processing facility with parking, a 17,000 square foot cold and dry storage building and a 3,200 square foot electrical building to support expansion of the egg laying hen ranch. Barnhart Ranch also plans to further expand its existing egg laying hen ranch by constructing two (2) more cage free barns resulting in an increase in the capacity of 732,000 hens.
