### **I. PROPOSAL**

California Resources Production Corp (facility S-1327) was first issued a Title V permit on November 28, 2012, which was last renewed on March 27, 2017. As required by District Rule 2520, the applicant is requesting a permit renewal. The existing Title V permit shall be reviewed and modified to reflect all applicable District and federal rules updated, removed, or added since the issuance of the last renewal of the Title V permit on March 27, 2017 to present.

The purpose of this evaluation is to provide the legal and factual basis for all updated applicable requirements and to determine if the facility will comply with these updated requirements. It also specifically identifies all additions, deletions, and/or changes made to permit conditions or equipment descriptions.

### **II. FACILITY LOCATION**

California Resources Production Corp (facility S-1327) is located at the Heavy Oil Western stationary source in Kern County, CA.

### **III. EQUIPMENT LISTING**

A detailed facility printout listing all permitted equipment at the facility is included as Attachment C.

### **IV. GENERAL PERMIT TEMPLATE USAGE**

The applicant does not propose to use any model general permit templates.

## VII. REQUIREMENTS NOT FEDERALLY ENFORCEABLE

For each Title V source, the District issues a single permit that contains the Federally Enforceable requirements, as well as the District-only requirements. The District-only requirements are not a part of the Title V Operating Permits. The terms and conditions that are part of the facility's Title V permit are designated as "Federally Enforceable Through Title V Permit".

For this facility, the following are not federally enforceable and will not be discussed in further detail:

### A. Rules Added/Updated

There are no new rules that are not federally enforceable being added at this time.

### B. Rules Not Updated

## VIII. PERMIT REQUIREMENTS

The purpose of this evaluation is to review changes to federally enforceable requirements; therefore, this compliance section will only address rules that have been amended or added since the issuance of the most recent renewal of this facility's Title V permit, which occurred on March 27, 2017.

### A. District Rule 2201 - New and Modified Stationary Source Review Rule

District Rule 2201 has been amended since this facility's last Title V permit was issued. However, the requirements of this rule are only triggered at the time the source undergoes a modification. All applicable requirements from any NSR permit actions have already been incorporated into the current Title V permit. The updated requirements of this rule are therefore not applicable at this time.



Current permit unit S-1327-208 has the following condition #7 that no longer applies as permits S-1326-435, S-1737-194 and S-1738-466 have all previously been cancelled. Therefore the following condition will be removed.

- ~~This unit is permitted as S-1326-435, S-1327-208, S-1737-194 and S-1738-466 and is approved to operate in Vintage Production's and Occidental's, or its subsidiary's, Light and Heavy Oil Western and Central stationary sources. [District Rule 2201]~~

Additionally, permit unit S-1327-210 has the following condition #7 that no longer applies as permit S-1326-443 has previously been cancelled. Therefore the following condition will be removed.

- ~~This unit is also permitted as S-1326-443. [District Rule 2201]~~

### **B. District Rule 2520 - Federally Mandated Operating Permits**

There are no federally applicable Greenhouse Gas (GHG) requirements for this source. It should be noted that the Mandatory Greenhouse Gas Reporting rule (40 CFR Part 98) is not included in the definition of an applicable requirement within Title V (per 40 CFR 71.2). Therefore, there will be no further discussion of GHG in this evaluation.

### **C. District Rule 4306 – Boilers, Steam Generators, and Process Heaters – Phase 3**

This rule limits NOx and CO emission from boilers, steam generators, and process heaters. The rule is applicable to gaseous or liquid fuel-fired boilers, steam generators, or process heaters with a heat input greater than 5 million Btu per hour. Permit units S-1327-32, -34, -35, -71, -208, -210, and -241 along with the units approved by outstanding ATC -219-0 are subject to this rule.

The rule was amended on December 17, 2020. The amended rule requires boilers, steam generators, and process heaters to meet the applicable NOx and CO limits listed in Table 2 on or after December 31, 2023 (for the categories of units at this facility) or Section 5.2. The facility must submit an emission control plan (ECP) and apply for ATC permits to modify their units subject to this rule by May 1, 2022 (for the categories of units at this facility) to comply with the revised emission limits.

The permittee has submitted an emission control plan (ECP) for Rules 4306 and 4320 in project S-1221267. In that project, the District concurred with the applicant that the subject units are already in compliance with Rule 4306. Therefore, continued compliance with this rule is expected.

**D. District Rule 4311 – Flares**

This rule limits VOC, NO<sub>x</sub>, and CO emissions from flares. Flares S-1327-42, -83, and -254 are subject to this rule.

The rule was amended on December 17, 2020. The amended rule requires operators of flares to meet the flare annual throughput thresholds in Table 2, or to meet revised VOC and NO<sub>x</sub> emission requirements listed in Table 3. The changes begin to come into effect on December 31, 2023. The facility is required to submit an Authority to Construct (ATC) permit to comply with the future requirements by July 1, 2022.

The permittee has obtained ATCs S-1327-42-13, -83-3, and -254-2 that limit each flare to flaring up to 25,000 MMBtu/yr to comply with future requirements of this rule. Therefore, continued compliance with this rule is expected.

**E. District Rule 4320 - Advanced Emission Reduction Options for Boilers, Steam Generators, and Process Heaters Greater than 5.0 MMBtu/hr**

This rule limits NO<sub>x</sub>, CO, SO<sub>2</sub>, and PM<sub>10</sub> emissions from boilers, steam generators, and process heaters. The rule is applicable to gaseous or liquid fuel-fired boilers, steam generators, or process heaters with a heat input greater than 5 million Btu per hour. Permit units S-1327-32, -34, -35, -71, -208, -210, and -241 along with the units approved by outstanding ATC -219-0 are subject to this rule.

The rule was amended on December 17, 2020. The amended rule requires units subject to the rule to meet the applicable NO<sub>x</sub> limits listed in Table 2 on or after December 31, 2023, pay an annual emissions fee as specified in Section 5.3, or comply with the applicable Low-Use Unit requirements of Section 5.5. The facility must submit an emission control plan and apply for ATC permits to modify their permit for units subject to this rule by May 1, 2022 to comply with the revised emission limits.

The permittee has submitted an emission control plan (ECP) for Rules 4306 and 4320 in project S-1221267. In the plan, the permittee requested to pay annual fees for these unit to comply with the future requirements of the rule. Therefore, continued compliance with this rule is expected.

**F. District Rule 4601 – Architectural Coatings**

This rule limits the emissions of VOCs from architectural coatings, and it specifies architectural coatings storage, cleanup, and labeling requirements.

This rule was amended on April 16, 2020. The amendments to the rule include the following:

- Numerous definitions were added, deleted or modified in order to make the amended rule harmonize with definitions and rule requirements presented in the California Air Resources Board (ARB) Suggested Control Measures (SCM).
- The amended rule implements the recommended VOC limits per the ARB SCM. The following changes were as follows: 15 coating categories were eliminated, 10 were added, 19 coatings categories remained unchanged, and the VOC content limits for 19 categories were lowered.
- The phrase "blends or repackages" was added to rule language to extend the applicability of rule language to facilities involved in those activities.
- A reporting requirement was added for any architectural coating that is sold in a container with a volume of one liter or less. The exemption for architectural coatings was further defined by adding "coatings that are supplied and offered for sale" to current language, in order to make the rule consistent with the ARB SCM.
- Labeling requirements were updated to add new labeling standards consistent with new coatings categories per the SCM.
- A new section was added to include reporting requirements per the SCM. The SCM contains a new requirement to submit sales data. Collection of this data is authorized in the California Health and Safety Code which requires submission of data to estimate emissions.
- New sections were added to coincide with new coating categories pursuant to the ARB SCM.
- The compliance schedule was updated to account for the new amendments to rule language by adding the phrase "the dates specified within the text of the rule."

The only reference to this rule is in the facility-wide permit (S-1327-0), specifically by conditions #23 through #25 and #40. The following existing conditions have been revised as shown in strikethrough/underline to reflect the changes to rule 4601 as follows:

23. No person shall manufacture, blend, repackage, supply, sell, solicit or apply any architectural coating with a VOC content in excess of the corresponding limit specified in ~~Table of Standards 1 effective until 12/30/10 or Table of Standards 2 effective on and after 1/1/11~~ Table 1 or Table 2 of District Rule 4601 (~~12/17/09~~ 4/16/20) for use or sale within the District. [District Rule 4601]
24. All VOC-containing materials subject to Rule 4601 (~~12/17/09~~ 4/16/20) shall be stored in closed containers when not in use. [District Rule 4601]
25. The permittee shall comply with all the Labeling and Test Methods requirements outlined in Rule 4601 sections 6.1 and 6.3 (~~12/17/09~~ 4/16/20). [District Rule 4601]

40. Compliance with permit conditions in the Title V permit shall be deemed in compliance with the following applicable requirements: SNUAPCD Rules 1100, sections 6.1 and 7.0 (12/17/92); 2010, sections 3.0 and 4.0 (12/17/92); 2031 (12/17/92); 2040 (12/17/92); 2070, section 7.0 (12/17/92); 2080 (12/17/92); 4101 (2/17/05); 4601 (~~12/17/09~~ 4/16/20); 8021 (8/19/2004); 8031 (8/19/2004); 8041 (8/19/2004); 8051 (8/19/2004); 8061 (8/19/2004); and 8071 (9/16/2004). A permit shield is granted from these requirements. [District Rule 2520]

Therefore, continued compliance with this rule is expected.

**G. 40 CFR 60 Subpart Kb - Standards of Performance for Volatile Organic Liquid Storage Vessels (Including Petroleum Liquid Storage Vessels) for Which Construction, Reconstruction, or Modification Commenced After July 23, 1984**

The subpart applies to each storage vessel with a capacity greater than or equal to 75 cubic meters (m<sup>3</sup>) that is used to store volatile organic liquids (VOL) for which construction, reconstruction, or modification is commenced after July 23, 1984.

This subpart was amended on January 19, 2021. The subpart was amended to offer an alternate means of compliance with Subpart Kb pursuant to Section 60.110b(e) by allowing the option to comply with part 63, subpart WW (National Emission Standards for Storage Vessels (tanks) – Control Level 2) of this chapter.

This subpart does not apply to storage vessels with a capacity greater than or equal to 151 m<sup>3</sup> storing a liquid with a maximum true vapor pressure (TVP) less than 3.5 kilopascals (kPa) or with a capacity greater than or equal to 75 m<sup>3</sup> but less than 151 m<sup>3</sup> storing a liquid with a maximum true vapor pressure less than 15.0 kPa.

All of the storage tanks at this facility are limited to storing liquids with TVPs less than 0.5 psia (equivalent to 3.5 kPa). Therefore, the tanks at the facility are not subject to this subpart.

**H. 40 CFR 60 Subpart OOOO – Standards of Performance for Crude Oil and Natural Gas Production, Transmissions and Distribution; and**

**Subpart OOOOa - Standards of Performance for Crude Oil and Natural Gas Facilities for which Construction, Modification or Reconstruction Commenced After September 18, 2015**

These subpart could potentially apply to this facility's tanks. However, pursuant to section §60.5365 (in Subpart OOOO) and §60.5365a (in Subpart OOOOa), these

subparts do not apply since the emissions from each of the tanks at the facility are all estimated to be less than 6 tons per year. Therefore, these subparts do not apply.

**I. 40 CFR Part 63 Subpart HH - National Emission Standards For Hazardous Air Pollutants From Oil And Natural Gas Production Facilities**

Subpart HH regulates the emissions of HAPs from oil and gas production facilities.

This subpart was amended on November 19, 2020. The subpart was amended to allow the initial notification requirement under § 63.775(c)(1), which previously required to be done no later than January 3, 2008, to now be done no later than 120 days after the source becomes subject to this subpart, whichever is later. This amendment does not affect the applicable requirements.

**J. 40 CFR 82 Subpart B – Servicing of Motor Vehicle Air Conditioners**

The purpose of 40 CFR Part 82 Subpart B is to implement section 609 of the Clean Air Act, as amended regarding the servicing of motor vehicle air conditioners (MVACs), and to implement section 608 of the Clean Air Act regarding certain servicing, maintenance, repair and disposal of air conditioners in MVACs and MVAC-like appliances.

These regulations apply to any person performing service on a motor vehicle for consideration when this service involves the refrigerant in the motor vehicle air conditioner.

This subpart was amended on amended July 17, 2019, August 23, 2019, and March 24, 2021. The amendments to this subpart did not have any effect on the current permit requirements and will therefore not be addressed further in this evaluation. The following condition on the draft renewed permit is a mechanism to ensure compliance with the requirements of this subpart:

**K. 40 CFR 82 Subpart F – Recycling and Emissions Reductions**

The purpose of 40 CFR Part 82 Subpart F is to reduce emissions of class I and class II refrigerants and their substitutes to the lowest achievable level by maximizing the recapture and recycling of such refrigerants during the service, maintenance, repair, and disposal of appliances and restricting the sale of refrigerants consisting in whole or in part of a class I and class II ODS in accordance with Title VI of the Clean Air Act.

These regulations apply to any person servicing, maintaining, or repairing appliances. This subpart also applies to persons disposing of appliances, including small appliances and motor vehicle air conditioners. In addition, this subpart applies to refrigerant reclaimers, technician certifying programs, appliance owners and operators, manufacturers of appliances, manufacturers of recycling and recovery equipment, approved recycling and recovery equipment testing organizations, persons selling class I or class II refrigerants or offering class I or class II refrigerants for sale, and persons purchasing class I or class II refrigerants.

This subpart was amended on December 27, 2017 and April 10, 2020. The amendments to this subpart did not have any effect on the current permit requirements and will therefore not be addressed further in this evaluation. The following condition on the draft renewed permit is a mechanism to ensure compliance with the requirements of this subpart:

**IX. PERMIT SHIELD**

A permit shield legally protects a facility from enforcement of the shielded regulations when a source is in compliance with the terms and conditions of the Title V permit. Compliance with the terms and conditions of the Operating Permit is considered compliance with all applicable requirements upon which those conditions are based, including those that have been subsumed.

**A. Requirements Addressed by Model General Permit Templates**

The applicant does not propose to use any model general permit templates.

## **B. Requirements not Addressed by Model General Permit Templates**

California Resources Production Corp is not requesting any new permit shields within this Title V renewal project. In addition, California Resources Production Corp is not requesting any changes to the existing permit shield already included in their Title V operating permit. Therefore, all of the existing permit shields will be maintained on the revised permit for this renewal project.
