## Emissions reduced during Health Air Living Week

With the goal of motivating individuals and organizations to try new and innovative strategies to clean up the Valley's air, the Air District dubbed July 7-13 "Healthy Air Living Week," bringing Valley-wide attention to the efforts and activities conducted to inaugurate the year-round initiative.

The intent was to serve as a catalyst for businesses, municipalities and individuals to explore new, air-friendly behaviors in a non-threatening fashion with the ability to revise, redirect and transition to ongoing and year-round behavioral changes.

The District actively demonstrated what can be done during Healthy Air Living Week as a full participant in the effort to reduce vehicle miles traveled through District staff using alternative means of transportation to and from work.

Staff in the Fresno, Bakersfield and Modesto offices chose to carpool, walk, take the bus or bike to work all week, as well as work together to further reduce vehicle miles traveled by bringing a sack lunch to work or ordering in as a group.

As a result, the District saw the following reductions:

- 381 lbs of emissions saved;
- 26,780 fewer miles traveled;
- 1,232 gallons of fuel not used; and
- \$5,545 dollars saved.

In addition, 23 organizations took such activities a step farther and participated in the Commute Green San Joaquin Challenge, actively competing against each other to see who could get the highest percentage of employees to use alternative commuting methods.

A total of 17, 278 employees were involved in the challenge with the following results for highest percentage rates going to:

**Small Category** (5 to 20 employees)  
Insight Environmental Consultants,  
Bakersfield

**Medium Category** (21 to 100 employees)  
Jeffrey / Scott Advertising, Fresno

**Large Category** (Over 100 employees)  
Community Recycling, Lamont

The Air District recognized these employers for winning the challenge with a plaque awarded at the District's August 21st Governing Board meeting and also gave each employer a bicycle as part of the "Green Bike" program, allowing employees to use the office bike to run errands instead of driving.

## Prius winner announced at Board meeting

One of the many exciting features of the Healthy Air Living initiative is the "Win a Toyota Prius" contest.

4,600 entries were taken to be placed in the drawing for the hybrid vehicle.

San Joaquin Valley residents, businesses, public agencies and faith-based organizations were able to enter by completing a Pledge card that stated the entrant would adopt a number of air-friendly behaviors to make them eligible.

Residents could also enter by test driving a hybrid vehicle or low-emissions vehicle at any Valley Toyota dealer.
