
The program credited with drastically reducing wintertime particulate matter (PM) pollution in the San Joaquin Valley begins its ninth season Nov. 1. Check Before You Burn prohibits residential wood burning on winter days when particle pollution from wood smoke may cause the Valley to exceed the federal health standard for PM.

From November through February, wood-burning forecasts are issued by county for the air basin. This includes San Joaquin, Stanislaus, Merced, Madera, Fresno, Kings, Tulare and the Valley portion of Kern counties.

Residential wood burning is the largest source of PM during winter months, emitting an average of 17 tons per day of the pollutant. The Valley's topography, meteorology and geography provide ideal conditions for a build-up of pollution at ground level during winter months. Health consequences of high levels of PM can include reduced lung function, asthma exacerbations, and an increase in the risk of heart attacks.

Although the Valley was declared in attainment of the federal health standard for PM10 (particulate matter 10 microns in diameter) in 2006, the air basin still fails to meet the more stringent standard for fine-particulate matter (PM2.5). But, even those levels are improving.

The graph below illustrates air quality during winter months from 1990 to last season with green indicating good air quality and red indicating bad.



Before lighting a fire in a wood-burning fireplace, a wood stove or pellet-fueled heater, make sure to Check Before You Burn by calling 1-800-SMOG-INFO or checking the Air District's website. You can also sign up on the District's website to receive automatic daily air quality forecasts and wood-burning declarations by e-mail.
