State provides truckers flexibility

The California Air Resources Board (CARB) is taking steps to help vehicle owners comply with the upcoming deadline of the state's truck and bus regulation.

The regulation requires that all small-fleet owners of heavy-duty trucks and buses operating in California retrofit at least one of their trucks with a particulate matter filter or replace the vehicle with a 2007 model year or newer engine by Jan. 1, 2014. Large fleets were required to comply by Jan. 1, 2012.

To assist operators who may have difficulty complying by the deadline date, CARB will recognize good-faith efforts to comply for fleet and vehicle owners who demonstrate they took action prior to the deadline.

Vehicle owners can avoid enforcement actions by reporting to the Truck Regulations Upload and Compliance Reporting System (TRUCRS) that they took any of the following steps by Jan. 1, 2014:

- Entered into an agreement with an authorized PM filter installer.
- Signed a purchase agreement to replace a truck with a 2007 or newer model year.
- Were approved or denied financing for a particulate matter filter retrofit.
- Have applied for a grant to replace an existing truck with one that meets 2010 or later emissions standards.

Affected owners have until Jan. 31, 2014 to report having taken such actions to (TRUCRS) for assurance of avoiding possible penalties, DMV registration holds or impoundment.
