## Funding available for Heavy Duty Waste Haulers

The Valley Air District is accepting applications to fund up to \$50,000 toward the cost of new waste transfer vehicles operating within the San Joaquin Valley.

Owners of heavy-duty trucks that haul waste have until May 19 to apply for this \$1.9 million program to replace their older, high-polluting trucks with new, cleaner and more efficient trucks.

This Request for Applications (RFA) is being issued to solid waste transportation companies and owner/operators hauling from waste transfer stations to landfills and waste facilities within the District boundaries. Funding priority will be given to trucks that travel exclusively within the Valley. The replacement trucks will be 90 percent cleaner than those they are replacing, helping the Valley meet critical air quality goals.

All applicants will be notified of their status and unfunded applications will be kept for future consideration as additional funds become available.

To be eligible for the program, existing trucks must:

- Be in compliance with all applicable state regulations
- Be currently in operation
- Have a gross vehicle weight rating of 26,001 lbs. or greater
- Be equipped with a 1996-2003 model year diesel engine

#### Time to mow? Go electric

This is the perfect time of year to take advantage of the Air District's incentive program that provides Valley residents with a substantial rebate when trading in their gas mower for an electric model.

Electric lawn mowers remove a significant amount of emissions from the air basin; for example, using one gas-powered mower for an hour produces emissions equivalent to driving 12 late-model cars for the same period of time.

Electric mowers are also lighter, quieter, easier to use and maintain, and work just as well as gas mowers. In addition there are no gas or oil spills and zero emissions.
