



## Protect your health by understanding the District's daily burn status

As the nights get colder in the Valley, some residents turn to fireplaces to keep their homes warm. The District encourages Valley residents to avoid wood burning altogether. Wood smoke contains particulate matter, which enters your house and neighborhood and can negatively impact your health.

Before using any kind of residential wood burning device November 1 through the end of February, please visit valleyair. org/burnstatus to determine if it is legal to burn that day. Please note: burning trash is always illegal.

Here are the three daily burn status options and what they mean:

No Burning for All: Residents cannot use their wood-burning devices from midnight to midnight. Violations can result in fines.

No Burning Unless Registered: Only residents with devices registered with the District can use their units. To be registered, these devices must meet EPA requirements or are pelletfueled, wood-burning heaters exempt from EPA-certification requirements.

Burning Discouraged: If residents must use their wood-burning devices, clean and dry firewood is encouraged. Unseasoned wood smolders and creates additional emissions.

The daily declarations are issued each afternoon for the next day and are based on what the particulate matter (PM) forecast will be for each county. For "Hot Spot" counties (Fresno, Madera and Kern) with bigger air quality challenges, the PM thresholds are more stringent and set at lower thresholds compared to other counties.
