A. <u>C-19-21E California Resources Production Corporation</u>

On November 12, 2019, Hearing Board Chair, Daniel Hartwig, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from November 29, 2019, to December 13, 2019.
