10. Stipulated Order of Abatement report:

A Stipulated Order of Abatement was granted by the Central Region Hearing Board on December 16, 2015, between the District and Agricultural Growers to allow the burning of orchard removal material in situations where no economically feasible option is available. The following represents the growers who have entered into the stipulation since the last Hearing:

- No growers have entered into the stipulation since the May 15, 2019, hearing.
- 11. The Central Region Hearing Board heard and granted the following emergency variance since the May 15, 2019, hearing.
  - A. <u>C-19-11E CertainTeed Corporation</u>

On June 18, 2019, Hearing Board Chair, Daniel Hartwig, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from June 28, 2019, through June 30, 2019. Said variance provided relief from specific requirements of District Rules 1080, 2070, 2201, 2520, 4101, and 4354, and allowed for continued glass manufacturing with excess visible emissions during the installation of a new Dry Electrostatic-Precipitator fan assembly.
