- 11. The Central Region Hearing Board heard and granted the following emergency variance since the October 16, 2019, hearing:
 - A. <u>C-19-19E Vitro Flat Glass, LLC.</u>

On November 12, 2019, Hearing Board member, Jerry Boren, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from November 11, 2019, to November 18, 2019. Said variance provided relief from the applicable sections of District Rules 1080, 2070, 2520, 2201, 4101, and 4354 and allowed for continued glass manufacturing with excess visible emissions while power was shut down to the three fields of the electrostatic precipitator so that repairs and maintenance could be performed on the electrical system.
