- 11. The Central Region Hearing Board heard and granted the following emergency variance since the June 17, 2020, hearing:
 - A. C-20-12E Guardian Industries LLC

On July 2, 2020, Hearing Board Chair, Daniel Hartwig, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from July 3, 2020, through July 10, 2020. The variance provided relief from specific requirements of District Rules 2070, 2201, 2520, 4101, and California Health & Safety Code section 41701 and allowed continued glass manufacturing with excess emissions while the exhaust stream bypasses the scrubber, electrostatic precipitator (EP), and SCR while Guardian performs maintenance of the EP.
