  - A. C-21-03E Guardian Industries, LLC

On February 5, 2021, Hearing Board Chair, Daniel Hartwig, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from February 5, 2021, through February 16, 2021. The variance provided relief from specific requirements of District Rules 2070, 2201, 2520, 4101, and California Health & Safety Code section 41701 and allowed continued glass manufacturing with excess visible emissions while the exhaust stream bypasses the scrubber, EP, and SCR while Guardian performs maintenance of the EP.
