- 10. The Central Region Hearing Board has heard and granted the following emergency variances:
 - A. C-21-19E Fresno Cogeneration Partners, LP

On October 6, 2021, Hearing Board Chair, Daniel Hartwig, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from October 2, 2021, through October 31, 2021. The variance provided relief from specific requirements of District Rules 1080, 2070, 2201, 2520, 4001, and 4703, and allowed for continued electric power generation while the CEMS is returned to functional status.

B. C-21-20E The Termo Company

On October 13, 2021, Hearing Board Chair, Daniel Hartwig, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from October 12, 2021, through November 9, 2021. The variance provided relief from specific requirements of District Rules 2070, 2201, and 4623, and allowed the continued storage of VOC containing liquids in the subject tanks without a functional and operating VRS while Termo repairs the VRS control module.

C. C-21-21E Baker Commodities Inc.

On October 29, 2021, Hearing Board Chair, Daniel Hartwig, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from October 28, 2021, through November 8, 2021. The variance provided relief from specific requirements of District Rules 2070 and 2520, and allowed Baker to be able to store received materials beyond 18 hours without processing.
