 - A. C-23-03E Rio Bravo Fresno

On January 24, 2023, Hearing Board Chair, Daniel Hartwig, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from January 17, 2023, through February 15, 2023. The variance provided relief from specific requirements of District Rules 2070, 2080, 2201, and 2520, and allowed Rio Bravo Fresno to continue operation with fugitive dust emissions while Broken windscreen is repaired and returned to compliant operation.

B. C-23-04E CRPC

On January 26, 2023, Hearing Board Chair, Daniel Hartwig, acting for and on behalf of the Central Region Hearing Board, approved an emergency variance from January 25, 2023, through February 15, 2023. The variance provided relief from specific requirements of District Rules 2010, 2070, 2201, and 4623, and allowed CRPC to continue operation without a functioning VRS until the underground wire is repaired/replaced.
