Mr. Houlihan presented the Staff Report

GUARDIAN has requested a short variance from the applicable requirements of District Rules 2070, 2201, 2520, 4101, and CH&SC section 41701, in addition to the applicable conditions of the subject permits. The requested short variance will be for a non-consecutive 108.67 hour period to occur sometime between August 19, 2020, and October 30, 2020, inclusive. If granted, the variance will allow the continued operation of the glass melting furnace, and continued glass production, with excess visible emissions while GUARDIAN shuts down the emission control devices in order to replace the SCR catalyst bed and perform additional routine maintenance on the EP.

<u>Petitioner Comments</u>: Mr. Roach commented that the facility did utilize approximately 6 hours from previous variance C-20-10S which brought the total available hours down to 102. Mr. Kalashian and Mr. Roach clarified that the variance is not expected to go over the 102 hours available. Mr. Rutterbush commented that it will take 72 hours to complete the replacement. He noted that this is the second replacement of the catalyst since the startup and continued that the replacement of the catalyst is a preventative maintenance measure.

<u>Hearing Board Comments</u>: Mr. Boren asked if the facility could delay the replacement of the catalyst until the temperatures cool down as we are currently in the middle of a heat wave. Mr. Rutterbush responded that the contractor availability is what is driving the schedule and the facility is locked into September.

CERTAINTEED has requested a short variance from the applicable requirements of District Rules 1080, 2070, 2201, 2520, 4101, 4354, and CH&SC section 41701, in addition to conditions of the subject permits. The requested short variance period would be for a consecutive 24 hour period to occur sometime between September 8, 2020, and September 10, 2020. If granted, the variance would allow the exhaust stream from the glass melting furnace to bypass the preconditioning chamber, caustic soda injection, EP, and CEMS while the repairs are performed on the EP. In addition, the variance would allow visible emissions as high as 95% opacity.
