GUARDIAN has requested a short variance from the applicable requirements of District Rules 2070, 2201, 2520, 4101, and CH&SC section 41701, in addition to the applicable conditions of the subject permits. The requested short variance will be for a non-consecutive 48 hour period to occur sometime between March 17, 2021, and April 30, 2021, inclusive. If granted, the variance will allow the continued operation of the glass melting furnace, and continued glass production, with excess visible emissions while GUARDIAN shuts down the emission control devices in order to perform routine maintenance on the EP.

VITRO has requested a short variance from the applicable requirements of District Rules 1080, 2070, 2201, 2520, 4101, 4354, and California Health and Safety Code (CH&SC) section 41701, in addition to the applicable conditions of the subject permits. The requested short variance will be for 15 consecutive days to occur sometime between April 11, 2021, and April 30, 2021, inclusive. If granted, the variance would allow the continued operation of the glass melting furnace and continued glass production while bypassing the emission control and monitoring systems so VITRO can perform maintenance on the EP. In addition the variance will allow excess visible emissions during the bypass.

<u>Petitioner Comments</u>: Mr. Zander commented that in the past the EP shutdown was usually done during the January – February timeframe. Taking into account some feedback from Hearing Board members the facility decided to delay the shutdown to April.
