Esthela Soto presented the Staff Report.

VITRO has requested a short variance from the applicable requirements of District Rules 1080, 2070, 2201, 2520, 4101, 4354, and California Health and Safety Code (CH&SC) section 41701, in addition to the applicable conditions of the subject permits. The requested short variance will be from January 22, 2023, to January 27, 2023. If granted, the variance would allow the continued operation of the glass melting furnace and continued glass production while bypassing the emission control and monitoring systems so VITRO can perform maintenance on the EP and ancillary equipment. In addition the variance will allow excess visible emissions during the bypass. Mr. Cuthbertson clarified that they do not expect to find any additional issues during the cleaning process because the furnace and EP were recently rebuilt.

Mr. Mulligan asked if the 144 hours will reset in January and Ms. Soto confirmed. Mr. Squire clarified that this is standard annual maintenance that usually takes place in January and it is not expected to happen again until 2024.

Mr. Robertson asked if all 144 hours are expected to be used. Mr. Squire explained that the maintenance should take approximately 120 hours.

Mr. Robertson asked for clarification if the variance is for excess visible emissions as well as bypassing of the emissions monitoring system and Ms. Soto confirmed.
