Gallo has requested a short variance from the applicable requirements of District Rules 2070, 2520, and 4354, in addition to the applicable conditions of the subject permits. The requested short variance would be effective from April 28, 2016, until July 26, 2016. If granted, the variance would allow for the postponement of the annual compliance source test for the four glass melting furnaces until Furnace #4 can be repaired and returned to normal operation.

City of Stockton has requested a short variance from applicable requirements of District Rules 2010, 2201, 2520, 4701, and 4702 in addition to the applicable conditions on the subject permits. The requested variance period would be from April 12, 2016, to April 22, 2016. If granted, it would allow for the operation of the three subject engines outside of their permitted O₂ exhaust gas concentration.

Mr. Houlihan asked if the intention of the petitioner was to test all three engines or just one. Mr. Johnson responded only one engine will be tested. Mr. Houlihan asked the other two engines be removed from the petition as noted in Recommendation 2C and modify the Recommendation:
