- 10. The Southern Region Hearing Board heard and granted the following emergency variances since the January 9, 2019, hearing:

A. S-19-01E California Resources Production Corporation

On January 29, 2019, Hearing Board Chair, William Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from January 31, 2019, through March 1, 2019. Said variance provided relief from specific requirements of District Rules 2070, 2520, and 4409, and allowed for an extension of repair period while CRPC schedules a workover rig to come to the facility and complete repairs.

B. <u>S-19-03E California Resources Production Corporation</u>

On February 20, 2019, Hearing Board Vice Chair, John Stovall, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from February 21, 2019, through March 22, 2019. Said variance provided relief from specific requirements of District Rules 2070, 2520, and 4409, and allowed for an extension of repair period while CRPC schedules a workover rig to come to the facility and complete repairs.

C. S-19-04E Double C Limited

On March 4, 2019, Hearing Board Chair, William Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from March 1, 2019, through March 30, 2019. Said variance provided relief from specific requirements of District Rules 1080, 2070, 2201, 2520, 4001, and 4703, and allowed for the continued operation of the subject turbine without a functional CEMS until the DAS maintenance is successful and the DAS is returned to reliable function.

D. S-19-06E Chevron U.S.A. Inc.

On March 19, 2019, Hearing Board Chair, William Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from March 18, 2019, through March 23, 2019. Said variance provided relief from specific requirements of District Rules 2010, 2070, 2201, 2520, 4401, and 4623, and allowed for the continued storage of VOC containing liquids in the subject tanks without a functional and operating VRS while the leak on the gas disposal line is repaired. In addition, it will allow wells with closed casing vents to produce into tanks that do not have a functional or operating VRS.
