10. The Southern Region Hearing Board heard and granted the following emergency variance since the April 10, 2019, hearing:

A. S-19-08E Aera Energy LLC

On April 25, 2019, Hearing Board Chair, William Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from April 25, 2019, through May 25, 2019. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520, 4401, and 4623, and allowed for the continued storage of VOC containing liquids in the subject tanks without a functional and operating VRS while the maintenance on the VRS is conducted. In addition, it will allow wells with closed casing vents to produce into tanks that do not have a functional or operating VRS.
