A. <u>S-20-27E Chevron U.S.A. Inc.</u>

On September 16, 2020, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from September 16, 2020, through September 23, 2020. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520, and 4623 allowed allow for the continued storage of VOC containing liquids in the subject tanks without a functional or operating VRS.

B. <u>S-20-29E BlueScope Buildings North America</u>

On September 23, 2020, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from September 23, 2020, through September 30, 2020. Said variance provided relief from specific requirements of District Rules 2070 and 2201 allowed allow for the continuation of the coatings operation while the VOC control equipment is shut down for repair.
