Mr. Kalashian presented the Staff Report.

Chevron has requested a short variance from the applicable requirements of District Rules 2010, 2070, 2201, 2520, 4401, and 4623 in addition to applicable conditions of the subject permits. The requested short variance would be for a consecutive 90 day period to occur sometime between December 12, 2018, and March 11, 2019, inclusive. If granted, the short variance would allow for the continued storage of VOC containing liquids in the tanks without a functional VRS while Chevron performs the proposed work. In addition, it will allow wells with closed casing vents to produce into tanks that do not have a functional or operating VRS.

Mr. Stovall asked what the estimation of the reduction of VOC would be.

Mr. Ericksen response that it will be a very small amount.

Petitioner Comments: Mr. Ericksen mentions that the facility is currently operating under an emergency variance and he just wanted to ensure to the Board that they have done all diligence to try to get this up and running before attending the Hearing today. If everything goes well on the commissioning, then they will not be using the vapor recovery system.

Kern Oil & Refining has requested a short variance from District Rule 2070, 2201, 2520, 4623, and 4455 in addition to conditions of the applicable permits. The requested short variance would be effective for a consecutive 48 hour period to occur sometime between December 12, 2018, and December 30, 2018, inclusive. If granted, the variance would allow Kern Oil & Refining to store VOC containing liquids in storage tanks without an operating or functional VRS while the VRS piping is replaced.

Mr. Stovall asked what the economic damage would be if the variance is not approved.

Ms. Hicks response that they did not prepare an economic estimate. There main concern is maintaining the facility in a safe operating situation. The only alternative that they would have would be to remove the contents from all the tanks and clean the tanks and go through the process of degassing and removing any sledge from the bottom.
