Taft Production Company has requested an interim variance, to be followed by a regular variance, from the applicable requirements of District Rules 2070, 2201, 2520, and 4309, in addition to applicable conditions of the subject permits. The requested variance period would be from May 6, 2021, through August 3, 2021, or until the petition for the regular variance can be heard, whichever occurs first. If granted, the variance would allow TPC to operate D1 with excess NOx emissions.

Mr. Neptune asked what the portable combustion analyzer results were for the month of February, since reporting is required monthly. Mr. Christensen responded that the results for February were missed due to personal turnover but results for the following and prior months were good.
