Esthela Soto presented the staff report.

A. CHEVRON has requested a short variance from the applicable requirements of District Rules 2010, 2070, 2201, 2520, 4401, and 4623, in addition to applicable conditions of the subject permits. The requested variance period would be for a non-consecutive 24 hour period to occur sometime between December 1, 2022, and January 1, 2023, inclusive. If granted, the variance would allow CHEVRON to continue to store VOC containing liquids in the subject tanks without an operating or functional VRS while PG&E conducts the proposed work.

Mr. Neptune asked for clarification on the effective date of the variance and Esthela Soto confirmed the date of December 12, 2022.

Dr. Moeller asked if the proposed variance period would be enough time for Chevron to complete scheduled maintenance. Lance Erickson shared that PG&E confirmed maintenance for December 12, 2022 but there is concern of possible delays with PG&E, which may require Chevron to seek further variance in 2023.
