ALON has requested a short variance from the applicable requirements of District Rules 2070, 2201, 2520, 4401, and 4623 in addition to the applicable condition of the subject permit. The requested variance would be for a consecutive 24 hour period to occur sometime between January 13, 2023 and February 12, 2023, inclusive. If granted, the variance would allow ALON to continue to store VOC containing liquids in the subject tanks without an operating or functional VRS while the work is completed.

Matthew Jalali noted that Alon Bakersfield Refining will be engaged in continuous monitoring to avoid excess emissions during the variance period.

Mr. Stovall asked for a cost breakdown if the variance was not granted. Matthew Jalali clarified that without a variance, maintenance could cost the facility up to \$2,000.00 per day.
