Board Member Worthley asked if the District will be allocating more resources towards disseminating air quality information to Valley elected officials and decision makers to make them aware of, and understand, the problems and challenges we face in cleaning the air.

Mr. Sadredin indicated the recommended budget contains significant resources for expanded public outreach. The recommended budget includes appropriations for a series of Town Hall meetings and a symposium. The District will seek participation by local elected officials, and other stakeholders at these events. Public outreach will also be a key part of our mission as we develop and implement a new comprehensive strategic plan. Mr. Sadredin also stated that in an ongoing effort to update local elected officials regarding District activities, staff publishes, and forwards highlights of Governing Board actions that take place during the meetings to local elected officials immediately after Governing Board Meetings. Additionally, the District will continue to publish an updated fact sheet illustrating District achievements in air quality challenges that lie ahead.
