4. PUBLIC COMMENT

5. REPORT FROM CITIZENS ADVISORY COMMITTEE (CAC)

Dennis Tristao, Chair of the CAC, presented the report. He stated the CAC received an excellent presentation on the PM10 Maintenance Plan, and an update on the Fast Track to Attainment. He stated the CAC also received an update on the new construction equipment rule and on the efforts the District is putting forth to receive a fair share of the Proposition 1B funding.

6. <u>SERVICE, TEAMWORK, ATTITUDE, RESPECT (S.T.A.R.) RECOGNITION</u> FOR YEARS <u>OF SERVICE</u>

Carolyn Rose, Director of Personnel, presented the list of District staff who had reached the five, ten, and fifteen year anniversaries. The Chair thanked the staff for their hard work and dedication.

7. HEALTH UPDATE: ADVERSE HEALTH EFFECTS FROM SHORT-TERM AND LONG-TERM EXPOSURE TO FINE PARTICULATE MATTER

Dr. Linda Smith, ARB, presented a PowerPoint slideshow on the health effects of PM2.5 and Cardiovascular Disease.

13. VERBAL REPORT: CALIFORNIA AIR RESOURCES BOARD (ARB)

Item 13 was taken out of order to accommodate the schedule of the ARB representative. Jeff Lindberg presented the report. Mr. Lindberg stated when ARB passed the District's Ozone Plan on June 14, they ordered the creation of a task force to find ways to beat the 2024 deadline. The first Task Force meeting will be held in Fresno on August 22. Additionally there will be town hall meetings in Parlier, Kearny, and Arvin to get public input.

8. HEALTH STUDY: APPROVE AGREEMENT WITH UCSF, IN AN AMOUNT NOT TO EXCEED \$256,000, TO CONDUCT A VALLEY SPECIFIC HEALTH STUDY DETERMINING THE RELATIVE CONTRIBUTION OF PM2.5 AND OZONE INDUCING LUNG INFLAMATION ON NON-ATOPIC ASTHMATICS

Seyed Sadredin, Executive Director/APCO, introduced Tim Tyner, Associate Director of the Center for Clinical Studies, Department of Medicine, UCSF in Fresno, and a professor at CSU Fresno. Mr. Tyner presented a PowerPoint illustrating his proposal. He stated the study intends to look at local effects of ozone and PM2.5 on Asthma, such as:

- How the different composition of PM2.5 in Valley communities affect lung health
- Whether chemical biomarkers can be used to track personal exposures to PM2.5 and select components.
- How interactions between environmental exposures, viral infections and genetic variation affects Valley residents.

10. IN-USE DIESEL ENGINE RETROFIT VERIFICATION PROGRAM UPDATE: DESCRIBE THE VERIFICATION PROCESS FOR IN-USE DIESEL ENGINES INCLUDING POTENTIAL RANGE OF COSTS AND CURRENT AND FUTURE AVAILABILITY OF VERIFIED RETROFIT DEVICES FOR INUSE ON-ROAD VEHICLES

Seyed Sadredin, Executive Director/APCO, stated that 80% of NOx in the Valley comes from mobile sources, and one way of controlling these emissions is with retrofit technology; however, retrofit devices must be verfied ARB, so he invited Shawn Daley, ARB manager of the Retrofit Technology Program, to speak on this subject for the benefit of the Board. Ms. Daley presented a PowerPoint in which she stated the objectives of verification are to determine if emissions reductions are real and durable, to determine if the emission reductions have been accurately quantified, and to ensure continued system performance. Additionally, Ms. Daley discussed verification requirements and considerations. She noted that there are six verified systems that reduce both PM and NOx. Ms. Daley stated the challenges to implementation are lack of significant emissions reductions, space constraints, temperature constraints, cost approaching or exceeding cost of engine, and failure of the user to adequately maintain the system.

Supervisor Barba asked what the cost per unit is. Ms. Daley stated it depends on type, but a large one may cost \$50,000. Supervisor Case asked if there are level three systems available. Ms. Daley stated the Swiss have a program, but although it reduces PM, it produces more NOx. She stated that device manufacturers are conservative in approaching ARB for certification.

11. <u>APPOINT A BOARD MEMBER TO SAN JOAQUIN VALLEY REGIONAL</u> PLANNING AGENCIES POLICY COUNCIL

The Chair suggested the standing Chair should be the appointee to the Policy Council to rotate with each new Chair. Supervisor Barba supported that suggestion.

Seyed Sadredin, Executive Director/APCO, stated the Evaluation Committee is to look at the performance of current Hearing Board Members and decide if they want to reappoint them. The Chair suggested each region meet on their own to evaluate their region's Hearing Board. The Chair suggested the following appointments: in the Northern Region, Supervisor O'Brien and Councilmember Vierra; in the Central Region, Supervisors Barba and Dominici; and in the Southern Region, Supervisors Worthley and McQuiston.

13. EXECUTIVE DIRECTOR/APCO COMMENTS

Seyed Sadredin, Executive Director/APCO, gave information on the upcoming Symposium scheduled for Visalia on October 3 and 4, 2007. He suggested a Board Retreat be scheduled for the morning of October 3rd. The Chair agreed. Mr. Sadredin stated the District has partnered with the Governor's Partnership for the San Joaquin Valley, and the Partnership will hold their meeting immediately following the Symposium. Additionally, Biztalk

will be held the following day in Visalia with the featured speakers Vincente Fox and Dominique Dawes.

Mr. Sadredin stated the District is working on calculating the carbon footprint of each City and County in the Valley to help them mitigate their air pollution. He also noted recent wildfires in Southern California have affected the Valley.

Mr. Sadredin stated that Senator Florez (D-Linden) amended SB240, and the District plans to support the measure at the opportune time. Mr. Sadredin stated EPA will reaffirm the Valley is in attainment for PM10.

14. GOVERNING BOARD MEMBER COMMENTS

Supervisor Nelson stated he and Supervisor Dominici met with Citizens Advisory Group of Industry (CAGI) and wanted to make sure other groups were aware that the Board Members are always willing to meet with groups that invite them. He noted the air seems quite clean this year. Supervisor Nelson stated he recently went on a public tour of Site 300 of Livermore National Lab in Tracey.
