I. PROPOSAL

Florestone, LLC was issued a Title V permit on December 31, 2004. As required by District Rule 2520, the applicant is requesting a permit renewal. The existing Title V permit shall be reviewed and modified to reflect all applicable District and federal rules updated, removed, or added since the issuance of the latest renewed Title V permit, renewed June 29, 2016.

The purpose of this evaluation is to provide the legal and factual basis for all updated applicable requirements and to determine if the facility will comply with these updated requirements. It also specifically identifies all additions, deletions, and/or changes made to permit conditions or equipment descriptions.

II. FACILITY LOCATION

Florestone, LLC is located at 2851 Falcon Drive in Madera, California.

III. EQUIPMENT LISTING

A detailed facility printout listing all permitted equipment at the facility is included as Attachment C.

IV. GENERAL PERMIT TEMPLATE USAGE

The applicant is requesting to use the following model general permit Templates:

A. Template SJV-UM-0-3 Facility Wide Umbrella

The applicant has requested to utilize template No. SJV-UM-0-3, <u>Facility Wide Umbrella</u>. Based on the information submitted in the Template Qualification Form, the applicant qualifies for the use of this template.

V. SCOPE OF EPA AND PUBLIC REVIEW

Certain segments of the proposed Renewed Operating Permit are based on model general permit templates that have been previously subject to EPA and public review. The terms and conditions from the model general permit templates are included in the proposed permit and are not subject to further EPA and public review.

For permit applications utilizing model general permit templates, public and agency comments on the District's proposed actions are limited to the applicant's eligibility for model general permit template, applicable requirements not covered by the model general permit template, and the applicable procedural requirements for issuance of Title V Operating Permits.

The following permit conditions, including their underlying applicable requirements, originate form model general permit templates and are not subject to further EPA or public review.

Conditions 1 through 40 of the requirements for permit unit C-495-0-4.

VII. REQUIREMENTS NOT FEDERALLY ENFORCEABLE

For each Title V source, the District issues a single permit that contains the Federally Enforceable requirements, as well as the District-only requirements. The District-only requirements are not a part of the Title V Operating Permits. The terms and conditions that are part of the facility's Title V permit are designated as "Federally Enforceable Through Title V Permit."

VIII. PERMIT REQUIREMENTS

The purpose of this evaluation is to review changes to federally enforceable requirements; therefore, this compliance section will only address rules that have been amended or added since the issuance of the initial Title V permit or most recent renewal of the Title V permit.

A. District Rule 2201 - New and Modified Stationary Source Review Rule (NSR)

District Rule 2201 has been amended since this facility's Title V permit was last renewed. However, the requirements of this rule are only triggered at the time the source undergoes a modification. All applicable requirements from any NSR permit actions have already been incorporated into the current Title V permit.

The following administrative modifications have been made to the Title V permit as described.

C-495-11-2: CNC EDGE TRIMMER SERVED BY AN OPEN FACE BOOTH SERVED BY TWO DONALDSON TORIT DUST COLLECTORS

The equipment description was revised to include the full manufacturer's name as follows,

CNC EDGE TRIMMER SERVED BY AN OPEN FACE BOOTH SERVED BY TWO DONALDSON TORIT DUST COLLECTORS

B. District Rule 2520 - Federally Mandated Operating Permits

District Rule 2520 has been amended since this Title V permit was last renewed. The rule was amended to enhance the public notice procedures for District actions that trigger public notification requirements under the existing provisions of the Rule by requiring electronic notification (e-notice) in place of newspaper publication. The amendment was done to be consistent with the EPA action that requires electronic notification (e-notice) in place of newspaper publication for EPA actions and for actions performed by other permitting authorities implementing federal permitting rules. The amendment to this rule does not have any effect on current permit requirements and therefore will not be addressed in this evaluation. However, greenhouse gas emissions will be addressed under Rule 2520 during this renewal.

Greenhouse Gas Discussion

There are no federally applicable Greenhouse Gas (GHG) requirements for this source. It should be noted that the Mandatory Greenhouse Gas Reporting rule (40 CFR Part 98) is not included in the definition of an applicable requirement within Title V (per 40 CFR 71.2). Therefore, there will be no further discussion of GHG in this evaluation.

C. District Rule 4101 - Visible Emissions

District Rule 4101 has not been modified since the facilities last Title V renewal. However, condition 1 on each current Permit to Operate is subject to this rule and is already listed on the current facility wide permit. Therefore, the condition is being removed from each individual permit and is included on proposed facility wide permit C-495-0-4 as condition number 22.

D. District Rule 4601 - Architectural Coatings

District Rule 4601 was amended on April 16, 2020. However, the amended rule is not SIP-approved by EPA. The previous version of this rule (amended December 17, 2009) is SIP-approved and is addressed by the District's facility wide umbrella template. Therefore, template SJV-UM-0-3 is still valid for this project.

E. 40 CFR Part 63, Subpart WWWW - <u>National Emissions Standards for Hazardous Air Pollutants: Reinforced Plastic Composites Production</u>

This subpart applies to reinforced plastic composites production facility located at a major source of Hazardous Air Pollutants emissions. 40 CFR 63, Subpart WWWW has been modified since the most recent permit renewal. The modification removed the exemption of emissions requirements during periods of startup, shutdown and malfunction. Language was updated to clarify a facility can be reclassified from a major source to an area source at any time. In addition, requirements were added to incorporate provisions for electronic reporting. These modifications did not result in any changes to permit conditions. No further discussion is required.

F. 40 CFR Part 64 - Compliance Assurance Monitoring (CAM)

40 CFR Part 64 requires Compliance Assurance Monitoring for units that meet the following three criteria:

- 1) the unit must have an emission limit for the pollutant;
- 2) the unit must have add-on controls for the pollutant; these are devices such as flue gas recirculation (FGR), baghouses, and catalytic oxidizers; and
- 3) the unit must have a pre-control potential to emit of greater than the major source thresholds.

a. <u>C-495-2-8: SHOWER STALL GEL SPRAY PROCESS #1 INCLUDING</u> MOLDS AND ASSOCIATED EQUIPMENT

This unit has a VOC emission limit however, it is not subject to CAM for VOC as it does not have an add-on control for VOC emissions.

This unit does not have an emission limit for NOx, SOx, PM10 or CO. Therefore, this unit is not subject to CAM for these pollutants.

b. <u>C-495-3-8: SHOWER STALL GEL SPRAY PROCESS #2 INCLUDING MOLDS AND ASSOCIATED EQUIPMENT</u>

This unit has a VOC emission limit however, it is not subject to CAM for VOC as it does not have an add-on control for VOC emissions.

This unit does not have an emission limit for NOx, SOx, PM10 or CO. Therefore, this unit is not subject to CAM for these pollutants.

c. <u>C-495-4-7: SHOWER STALL CHOP SPRAY PROCESS #1 INCLUDING MOLDS, SIX BINK AIR SPRAY BOOTHS AND ONE WARM AIR TUNNEL FOR DRYING. (THE SPRAY BOOTHS AND AIR TUNNEL ARE COMMON TO THIS PERMIT AND C-495-5)</u>

This unit has a VOC emission limit however, it is not subject to CAM for VOC as it does not have an add-on control for VOC emissions.

This unit does not have an emission limit for NOx, SOx, PM10 or CO. Therefore, this unit is not subject to CAM for these pollutants.

d. C-495-5-7: SHOWER STALL CHOP SPRAY PROCESS #2 INCLUDING MOLDS, SIX BINK SPRAY BOOTHS AND ONE WARM AIR TUNNEL FOR DRYING. (SPRAY BOOTHS AND WARM AIR TUNNEL ARE COMMON TO THIS PERMIT AND C-495-4)

This unit has a VOC emission limit however, it is not subject to CAM for VOC as it does not have an add-on control for VOC emissions.

This unit does not have an emission limit for NOx, SOx, PM10 or CO. Therefore, this unit is not subject to CAM for these pollutants.

e. C-495-6-7: TERAZZO SHOWER RECEPTOR PROCESS INCLUDING ONE 10 CF ESSICK MIXER, AND FIVE GRINDING BOOTHS EACH SERVED BY A TORIT MODEL ECB-2 DUST COLLECTOR

Unit C-495-6-7 may be subject to CAM for PM10 as there is a PM10 limit on the permit, and it does have add-on controls in the form of dust collectors. However, as shown below, the pre-control potential to emit is not greater than the major source threshold of 140,000 pounds PM10/year.

Per current permit, this unit shall not emit more than 3.3 lb-PM10/day. Assuming the dust collectors have a control efficiency of 99% and the operation can operate 365 day/year for worst case emissions. The uncontrolled emissions are calculated as follow.

Uncontrolled PE = (Daily Emissions \div (1 – Control Efficiency)) x 365 day/year

= $(3.3 \text{ lb-PM10/day} \div (1 - 0.99)) \times 365 \text{ day/year}$ = 120,450 lb-PM10/year

f. C-495-7-4: 18,000 GALLON POLYESTER RESIN STORAGE SYSTEM INCLUDING THREE 6,000 GALLON TANKS ON THE EAST SIDE OF BUILDING "A" SUPPLYING THE MOLDING DEPARTMENT

This permit unit is not subject to CAM, since it does not have any emission limits.

g. C-495-8-4: 18,000 GALLON POLYESTER RESIN STORAGE SYSTEM INCLUDING THREE 6,000 GALLON TANKS ON THE WEST SIDE OF BUILDING "A" SUPPLYING THE FIBERGLASS MOLDING DEPARTMENT

This permit unit is not subject to CAM, since it does not have any emission limits.

h. <u>C-495-9-4: PANEL TRIM ROOM SERVED BY TWO TORIT MODEL</u> ECCCB-2 MODULAR DUST COLLECTOR

This permit unit is not subject to CAM, since it does not have any emission limits.

 C-495-10-3: RESIN TRANSFER MOLDING PROCESS INCLUDING ONE MOLDING STATION EQUIPPED WITH MOLDS, PUMPS, VACUUM, FINISH EQUIPMENT, AND CONVEYING EQUIPMEN

This unit is not subject to CAM as it is not equipped with any add on-control.

j. <u>C-495-11-2: CNC EDGE TRIMMER SERVED BY AN OPEN FACE BOOTH</u> SERVED BY TWO DONALDSON TORIT DUST COLLECTORS

Unit C-495-11-2 may be subject to CAM for PM10 as there is a PM10 limit on the permit, and it does have add-on controls in the form of dust collectors. However, as shown below, the pre-control potential to emit is not greater than the major source threshold of 140,000 pounds PM10/year.

Per current permit, this unit shall not process more than 45 tons/day or emit more than 0.0879 lb-PM/ton of product processed. Assuming the dust collectors have a control efficiency of 99% and the operation can operate 365 day/year for worst case emissions. The uncontrolled emissions are calculated as follow.

Uncontrolled PE = [(Daily Throughput x Emission Factor) \div (1 - Control Efficiency)] x 365 day/year = [(45 tons/day x 0.0879 lb-PM/ton) \div (1- 0.99)] x 365 day/year = 144,376 lb-PM/year

Assuming 50% of PM is PM10,

Uncontrolled PE = 144,376 lb-PM/year x 0.5 lb-PM10/1 lb-PM = 72,188 lb-PM10/year

G. 40 CFR Part 68 - Chemical Accident Prevention Provisions

40 CFR 68 was amended since the previous renewed TV permit was issued. However, the amendments to this subpart do not have any effect on existing permit requirements as addressed by condition 47 on permit C-495-0-4 of the draft renewed permit.

IX. PERMIT SHIELD

A permit shield legally protects a facility from enforcement of the shielded regulations when a source is in compliance with the terms and conditions of the Title V permit. Compliance with the terms and conditions of the Operating Permit is considered compliance with all applicable requirements upon which those conditions are based, including those that have been subsumed.

A. Requirements Addressed by Model General Permit Templates

Model General Permit Template SJV-UM-0-3

By submitting Model General Permit Template SJV-UM-0-3 qualification form, the applicant has requested that a permit shield be granted for all the applicable requirements identified by the template. Therefore, the permit shields as granted in Model General Permit Template is included as conditions 39 and 40 of the facility-wide requirements (C-495-0-3).

X. CALIFORNIA ENVIRONMENTAL QUALITY ACT

The purpose of the Title V permit renewal is to update the permit to ensure that any changes to regulations since the issuance of the initial Title V permit or most recent renewal of the Title V permit are incorporated as permit requirements.

Per the California Environmental Quality Act (CEQA) Statute §21080.24, and CEQA Guidelines §15281, the issuance, modification, amendment, or renewal of

any permit by an air pollution control district or air quality management district pursuant to Title V is exempt from CEQA, unless the issuance, modification, amendment, or renewal authorizes a physical or operational change to a source or facility. There will be no physical or operational change to the source or facility nor will the Title V permit renewal authorize a physical or operational change to the source or facility. Therefore, this project, a Title V permit renewal, is subject to a ministerial action that is exempt from CEQA.

EXPIRATION D **FACILITY:** C-495-0-4

FACILITY-WIDE REQUIREMENTS

- 1. {4362} The owner or operator shall notify the District of any breakdown condition as soon as reasonably possible, but no later than one hour after its detection, unless the owner or operator demonstrates to the District's satisfaction that the longer reporting period was necessary. [District Rule 1100, 6.1; County Rules 110 (Fresno, Stanislaus, San Joaquin); 109 (Merced); 113 (Madera); and 111 (Kern, Tulare, Kings)] Federally Enforceable Through Title V Permit
- {4363} The District shall be notified in writing within ten days following the correction of any breakdown condition. The breakdown notification shall include a description of the equipment malfunction or failure, the date and cause of the initial failure, the estimated emissions in excess of those allowed, and the methods utilized to restore normal operations. [District Rule 1100, 7.0; County Rules 110 (Fresno, Stanislaus, San Joaquin); 109 (Merced); 113 (Madera); and 111 (Kern, Tulare, Kings)] Federally Enforceable Through Title V Permit
- {4364} The owner or operator of any stationary source operation that emits more than 25 tons per year of nitrogen oxides or reactive organic compounds, shall provide the District annually with a written statement in such form and at such time as the District prescribes, showing actual emissions of nitrogen oxides and reactive organic compounds from that source. [District Rule 1160, 5.0] Federally Enforceable Through Title V Permit
- {4365} Any person building, altering or replacing any operation, article, machine, equipment, or other contrivance, the use of which may cause the issuance of air contaminants or the use of which may eliminate, reduce, or control the issuance of air contaminants, shall first obtain an Authority to Construct (ATC) from the District unless exempted by District Rule 2020 (12/20/07). [District Rule 2010, 3.0 and 4.0; and 2020] Federally Enforceable Through Title V Permit
- {4366} The permittee must comply with all conditions of the permit including permit revisions originated by the District. All terms and conditions of a permit that are required pursuant to the Clean Air Act (CAA), including provisions to limit potential to emit, are enforceable by the EPA and Citizens under the CAA. Any permit noncompliance constitutes a violation of the CAA and the District Rules and Regulations, and is grounds for enforcement action, for permit termination, revocation, reopening and reissuance, or modification; or for denial of a permit renewal application. [District Rules 2070, 7.0; 2080; and 2520, 9.8.1 and 9.13.1] Federally Enforceable Through Title V Permit
- {4367} A Permit to Operate or an Authority to Construct shall not be transferred unless a new application is filed with and approved by the District. [District Rule 2031] Federally Enforceable Through Title V Permit
- 7. {4368} Every application for a permit required under Rule 2010 (12/17/92) shall be filed in a manner and form prescribed by the District. [District Rule 2040] Federally Enforceable Through Title V Permit
- {4369} The operator shall maintain records of required monitoring that include: 1) the date, place, and time of sampling or measurement; 2) the date(s) analyses were performed; 3) the company or entity that performed the analysis; 4) the analytical techniques or methods used; 5) the results of such analysis; and 6) the operating conditions at the time of sampling or measurement. [District Rule 2520, 9.4.1] Federally Enforceable Through Title V Permit

- 9. {4370} The operator shall retain records of all required monitoring data and support information for a period of at least 5 years from the date of the monitoring sample, measurement, or report. Support information includes copies of all reports required by the permit and, for continuous monitoring instrumentation, all calibration and maintenance records and all original strip-chart recordings. [District Rule 2520, 9.4.2] Federally Enforceable Through Title V Permit
- 10. {4371} The operator shall submit reports of any required monitoring at least every six months unless a different frequency is required by an applicable requirement. All instances of deviations from permit requirements must be clearly identified in such reports. [District Rule 2520, 9.5.1] Federally Enforceable Through Title V Permit
- 11. {4372} Deviations from permit conditions must be promptly reported, including deviations attributable to upset conditions, as defined in the permit. For the purpose of this condition, promptly means as soon as reasonably possible, but no later than 10 days after detection. The report shall include the probable cause of such deviations, and any corrective actions or preventive measures taken. All required reports must be certified by a responsible official consistent with section 10.0 of District Rule 2520 (6/21/01). - 12. {4373} If for any reason a permit requirement or condition is being challenged for its constitutionality or validity by a court of competent jurisdiction, the outcome of such challenge shall not affect or invalidate the remainder of the conditions or requirements in that permit. [District Rule 2520, 9.7] Federally Enforceable Through Title V Permit
- 13. {4374} It shall not be a defense for a permittee in an enforcement action that it would have been necessary to halt or reduce the permitted activity in order to maintain compliance with the conditions of the permit. [District Rule 2520, 9.8.2] Federally Enforceable Through Title V Permit
- 14. {4375} The permit may be modified, revoked, reopened and reissued, or terminated for cause. The filing of a request by the permittee for a permit modification, revocation and reissuance, or termination, or a notification of planned changes or anticipated noncompliance does not stay any permit condition. - 15. {4376} The permit does not convey any property rights of any sort, or any exclusive privilege. [District Rule 2520, 9.8.4] Federally Enforceable Through Title V Permit
- 16. {4377} The Permittee shall furnish to the District, within a reasonable time, any information that the District may request in writing to determine whether cause exists for modifying, revoking and reissuing, or terminating the permit or to determine compliance with the permit. Upon request, the permittee shall also furnish to the District copies of records required to be kept by the permit or, for information claimed to be confidential, the permittee may furnish such records directly to EPA along with a claim of confidentiality.
