I. PROPOSAL

Grade 6 Oil, LLC was issued an initial Title V permit on October 24, 2014. As required by District Rule 2520, the applicant is requesting a permit renewal. The existing Title V permit has been reviewed and modified to reflect all applicable District and federal rules updated, removed, or added since the issuance of the last renewed Title V permit.

The purpose of this evaluation is to provide the legal and factual basis for all updated applicable requirements and to determine if the facility will comply with these updated requirements. It also specifically identifies all additions, deletions, and/or changes made to permit conditions or equipment descriptions.

II. FACILITY LOCATION

The facility is located at Section 6, T29S, R28E in Kern River oil field in Kern County.

III. EQUIPMENT LISTING

A detailed report listing all the permitted equipment at the facility is included as Attachment C.

IV. GENERAL PERMIT TEMPLATE USAGE

The applicant does not propose to use any model general permit templates.

V. SCOPE OF EPA AND PUBLIC REVIEW

VII. REQUIREMENTS NOT FEDERALLY ENFORCEABLE

For each Title V source, the District issues a single permit that contains the Federally Enforceable requirements, as well as the District-only requirements. The District-only requirements are not a part of the Title V Operating Permits. The terms and conditions that are part of the facility's Title V permit are designated as "Federally Enforceable Through Title V Permit".

For this facility, the following are not federally enforceable and will not be discussed in further detail:

A. Rules Adopted or updated:

There have been no rules adopted or updated since the initial Title V permit was issued.

VIII. PERMIT REQUIREMENTS

The purpose of this evaluation is to review changes to federally enforceable requirements; therefore, this compliance section will only address rules that have been amended or added since the issuance of the initial Title V permit.

1. District Rule 2020 - Exemptions

District Rule 2020 lists equipment which is specifically exempt from obtaining permits and specifies record keeping requirements to verify such exemptions. The amendments to this rule do not have any effect on current permit requirements and will therefore not be addressed in this evaluation.

2. District Rule 2201 - New and Modified Stationary Source Review Rule

District Rule 2201 has been amended since facility's Title V permit was last renewed. However the requirements of this rule are only triggered at the time the source undergoes a modification. All applicable requirements from any NSR permit actions have already been incorporated into current Title V permit.

3. District Rule 2410 – Prevention of Significant Deterioration

This District Rule has been newly adopted since facility's last Title V was last renewed. However the requirements of this rule are only triggered at the time the source undergoes a modification. All applicable requirements from any PSD permit actions have already been incorporated into current Title V permit.

4. District Rule 2520 - Federally Mandated Operating Permits

District Rule 2520 has been amended since this facility's Title V permit was last renewed. The amendments to this rule were administrative, relating only to the notification procedures for Title V permit modifications that are required to go through a public notice. The amendments to this rule did not have any effect

on current permit requirements and will therefore not be addressed further in this evaluation. However, greenhouse gas emissions will be addressed under Rule 2520 during this renewal.

Greenhouse Gas Discussion

There are no federally applicable Greenhouse Gas (GHG) requirements for this source. It should be noted that the Mandatory Greenhouse Gas Reporting rule (40 CFR Part 98) is not included in the definition of an applicable requirement within Title V (per 40CFR 71.2). Therefore, there will be no further discussion of GHG in this evaluation.

5. District Rule 4306 – <u>Boilers, Steam Generators, and Process Heaters –</u> Phase 3

This rule was amended on December 17, 2020, but the rule amendments have not been incorporated into the SIP. The amended rule is as stringent as the SIP approved version of the rule that was adopted on October 16, 2008.

The requirements in the amended version of the rule will not take effect until December 31, 2029. The rule requires the facility to submit an Authority to Construct permit application to implement the amended requirements. Compliance with the new requirements will therefore be addressed later, in accordance with the compliance schedule specified in the rule, through the ATC process and appropriate Title V permit modification process. The following condition on the draft renewed permits are a mechanism to ensure compliance with these requirements.

S-7858-1-2, -2-2, -21-1, and -22-1 - 85.0 MMBtu/hr Natural Gas-Fired Steam Generators

 The owner or operator of a boiler subject to the Tier 2 emission requirements of District Rules 4306 and 4320 shall submit to the APCO an emission control plan pursuant to Section 6.4 of each rule, and shall comply with all other applicable deadlines in Section 7.0 of these rules. [District Rules 4306 and 4320]

6. District Rule 4320 – <u>Advanced Emission Reduction Options For Boilers</u>, <u>Steam Generators</u>, and <u>Process Heaters Greater Than 5.0 MMBtu/hr</u>

This rule was amended on December 17, 2020, but the rule amendments have not been incorporated into the SIP. The amended rule is as stringent as the SIP approved version of the rule that was adopted on October 16, 2008.

The requirements in the amended version of the rule will not take effect until December 31, 2023. The rule requires the facility to submit an Authority to Construct permit application to implement the amended requirements.

Compliance with the new requirements will therefore be addressed later, in accordance with the compliance schedule specified in the rule, through the ATC process and appropriate Title V permit modification process. The following condition on the draft renewed permits are a mechanism to ensure compliance with these requirements.

S-7858-1-2, -2-2, -21-1, and -22-1 - 85.0 MMBtu/hr Natural Gas-Fired Steam Generators

 The owner or operator of a boiler subject to the Tier 2 emission requirements of District Rules 4306 and 4320 shall submit to the APCO an emission control plan pursuant to Section 6.4 of each rule, and shall comply with all other applicable deadlines in Section 7.0 of these rules. [District Rules 4306 and 4320]

7. District Rule 4601 – Architectural Coatings

This rule was amended on April 16, 2020, but the rule amendments have not been incorporated into the SIP. The amended rule is as stringent as the SIP approved version of the rule that was adopted on December 17, 2009. Therefore, the following conditions are still valid for this project.

S-7858-0-2: Facility-Wide Requirements

 Conditions 23 through 25 of the requirements of the draft renewed facilitywide permit is a mechanism to ensure compliance with this rule.

8. 40 CFR Part 64 – Compliance Assurance Monitoring

40 CFR Part 64 requires Compliance Assurance Monitoring (CAM) for units that meet the following three criteria:

- 1) The unit must have an emission limit for the pollutant;
- 2) The unit must have add-on controls for the pollutant; these are devices such as flue gas recirculation (FGR), baghouses, and catalytic oxidizers; and
- 3) The unit must have a pre-control potential to emit of greater than the major source thresholds.

a. <u>S-7858-1-2, -2-2, -21-1, and -22-1</u> - 85.0 MMBtu/hr Natural Gas-Fired Steam Generators

These permit units have emissions limits for SOx, PM₁₀, CO, and VOC but it does not have add-on controls for these criteria pollutants. Therefore, these permits unit are not subject to CAM for SOx, PM₁₀, CO, and VOC.

These permit units may be subject to CAM for NOx since there is a NOx limit, and it has add-on controls in the form of FGR. However, the pre-control NOx potential to emit is less than the major source threshold of 20,000 pounds NOx/year as shown below. Therefore, these units are not subject to CAM.

The North American Ultra Low NOx GLE burner is grantee to have 15 ppmv (equal to 0.0186 lb/MMBtu) NOx emissions without use of FGR. The unit's NOx emission without use of FGR is calculated below.

 $0.0186 \text{ lb NOx/MMBtu} \times 85.0 \text{ MMBtu/hr} \times 8,760 \text{ hrs/year} = 13,850 \text{ lbs NOx/year}$

b. <u>S-7858-3-5</u> - TEOR operation with well casing vented to vapor control system

This permit unit doesn't have a VOC limit, therefore it is not subject to CAM for VOC.

c. <u>S-7858-4-3, -5-5, -6-2, -7-2, -8-3, -9-3, -10-3, -11-2, -11-2, -13-2, 14-4, -15-2, -16-2, -17-2, -18-2, -19-2, -23-1, and -24-2 Crude Oil Storage Tanks</u>

These permit units do not have VOC emissions limit, therefore these are not subject to CAM for VOC.

IX. PERMIT SHIELD

A permit shield legally protects a facility from enforcement of the shielded regulations when a source is in compliance with the terms and conditions of the Title V permit. Compliance with the terms and conditions of the Operating Permit is considered compliance with all applicable requirements upon which those conditions are based, including those that have been subsumed.

A. Requirements Addressed by Model General Permit Templates

The applicant does not propose to use any model general permit templates.

B. Requirements not Addressed by Model General Permit Templates

This Title V permit renewal application does not include any proposals for new permit shields or modifications to any pre-existing permit shields. The proposed renewed Title V permit therefore does not include any new or modified permit shields.

C. Obsolete Permit Shields from Existing Permit Requirements

The original permits did not contain any obsolete permit shields.

EXPIRATION D FACILITY: S-7858-0-2

FACILITY-WIDE REQUIREMENTS

- 1. The owner or operator shall notify the District of any breakdown condition as soon as reasonably possible, but no later than one hour after its detection, unless the owner or operator demonstrates to the District's satisfaction that the longer reporting period was necessary. [District Rule 1100, 6.1 and Kern County Rule 111] Federally Enforceable Through Title V Permit
- The District shall be notified in writing within ten days following the correction of any breakdown condition. The breakdown notification shall include a description of the equipment malfunction or failure, the date and cause of the initial failure, the estimated emissions in excess of those allowed, and the methods utilized to restore normal operations. [District Rule 1100, 7.0 and Kern County Rule 111] Federally Enforceable Through Title V Permit
- The owner or operator of any stationary source operation that emits more than 25 tons per year of nitrogen oxides or reactive organic compounds, shall provide the District annually with a written statement in such form and at such time as the District prescribes, showing actual emissions of nitrogen oxides and reactive organic compounds from that source. [District Rule 1160, 5.0] Federally Enforceable Through Title V Permit
- {4365} Any person building, altering or replacing any operation, article, machine, equipment, or other contrivance, the use of which may cause the issuance of air contaminants or the use of which may eliminate, reduce, or control the issuance of air contaminants, shall first obtain an Authority to Construct (ATC) from the District unless exempted by District Rule 2020 (12/20/07). [District Rule 2010, 3.0 and 4.0; and 2020] Federally Enforceable Through Title V **Permit**
- {4366} The permittee must comply with all conditions of the permit including permit revisions originated by the District. All terms and conditions of a permit that are required pursuant to the Clean Air Act (CAA), including provisions to limit potential to emit, are enforceable by the EPA and Citizens under the CAA. Any permit noncompliance constitutes a violation of the CAA and the District Rules and Regulations, and is grounds for enforcement action, for permit termination, revocation, reopening and reissuance, or modification; or for denial of a permit renewal application. [District Rules 2070, 7.0; 2080; and 2520, 9.8.1 and 9.13.1] Federally Enforceable Through Title V Permit
- {4367} A Permit to Operate or an Authority to Construct shall not be transferred unless a new application is filed with and approved by the District. [District Rule 2031] Federally Enforceable Through Title V Permit
- {4368} Every application for a permit required under Rule 2010 (12/17/92) shall be filed in a manner and form 7. prescribed by the District. [District Rule 2040] Federally Enforceable Through Title V Permit
- 8. {4369} The operator shall maintain records of required monitoring that include: 1) the date, place, and time of sampling or measurement; 2) the date(s) analyses were performed; 3) the company or entity that performed the analysis; 4) the analytical techniques or methods used; 5) the results of such analysis; and 6) the operating conditions at the time of sampling or measurement. [District Rule 2520, 9.4.1] Federally Enforceable Through Title V Permit
- {4370} The operator shall retain records of all required monitoring data and support information for a period of at least 5 years from the date of the monitoring sample, measurement, or report. Support information includes copies of all reports required by the permit and, for continuous monitoring instrumentation, all calibration and maintenance records and all original strip-chart recordings. [District Rule 2520] Federally Enforceable Through Title V Permit

- 10. {4371} The operator shall submit reports of any required monitoring at least every six months unless a different frequency is required by an applicable requirement. All instances of deviations from permit requirements must be clearly identified in such reports. [District Rule 2520, 9.5.1] Federally Enforceable Through Title V Permit
- 11. {4372} Deviations from permit conditions must be promptly reported, including deviations attributable to upset conditions, as defined in the permit. For the purpose of this condition, promptly means as soon as reasonably possible, but no later than 10 days after detection. The report shall include the probable cause of such deviations, and any corrective actions or preventive measures taken. All required reports must be certified by a responsible official consistent with section 10.0 of District Rule 2520 (6/21/01). - 12. {4373} If for any reason a permit requirement or condition is being challenged for its constitutionality or validity by a court of competent jurisdiction, the outcome of such challenge shall not affect or invalidate the remainder of the conditions or requirements in that permit. [District Rule 2520, 9.7] Federally Enforceable Through Title V Permit
- 13. {4374} It shall not be a defense for a permittee in an enforcement action that it would have been necessary to halt or reduce the permitted activity in order to maintain compliance with the conditions of the permit. [District Rule 2520, 9.8.2] Federally Enforceable Through Title V Permit
- 14. {4375} The permit may be modified, revoked, reopened and reissued, or terminated for cause. The filing of a request by the permittee for a permit modification, revocation and reissuance, or termination, or a notification of planned changes or anticipated noncompliance does not stay any permit condition. - 15. {4376} The permit does not convey any property rights of any sort, or any exclusive privilege. [District Rule 2520, 9.8.4] Federally Enforceable Through Title V Permit
- 16. {4377} The Permittee shall furnish to the District, within a reasonable time, any information that the District may request in writing to determine whether cause exists for modifying, revoking and reissuing, or terminating the permit or to determine compliance with the permit. Upon request, the permittee shall also furnish to the District copies of records required to be kept by the permit or, for information claimed to be confidential, the permittee may furnish such records directly to EPA along with a claim of confidentiality.
