I. PROPOSAL

Pacific Pipeline System, LLC was issued their last Title V permit renewal on August 1, 2016. As required by District Rule 2520, the applicant is requesting a permit renewal. The existing Title V permit shall be reviewed and modified to reflect all applicable District and federal rules updated, removed, or added since the issuance of the initial Title V permit.

The purpose of this evaluation is to provide the legal and factual basis for all updated applicable requirements and to determine if the facility will comply with these updated requirements. It also specifically identifies all additions, deletions, and/or changes made to permit conditions or equipment descriptions.

II. FACILITY LOCATION

Pacific Pipeline System, LLC is located at 11100 Hwy 166 in Mettler, CA.

III. EQUIPMENT LISTING

A detailed facility printout listing all permitted equipment at the facility is included as Attachment C.

IV. GENERAL PERMIT TEMPLATE USAGE

The applicant is requesting to use the following model general permit Templates:

A. Template SJV-UM-0-3 Facility Wide Umbrella

The applicant has requested to utilize template No. SJV-UM-0-3, <u>Facility Wide Umbrella</u>. Based on the information submitted in the Template Qualification Form, the applicant qualifies for the use of this template.

V. SCOPE OF EPA AND PUBLIC REVIEW

Certain segments of the proposed Renewed Operating Permit are based on model general permit templates that have been previously subject to EPA and public review. The terms and conditions from the model general permit templates are included in the proposed permit and are not subject to further EPA and public review.

For permit applications utilizing model general permit templates, public and agency comments on the District's proposed actions are limited to the applicant's eligibility for model general permit template, applicable requirements not covered by the model general permit template, and the applicable procedural requirements for issuance of Title V Operating Permits.

The following permit conditions, including their underlying applicable requirements, originate form model general permit templates and are not subject to further EPA or public review.

VII. REQUIREMENTS NOT FEDERALLY ENFORCEABLE

For each Title V source, the District issues a single permit that contains the Federally Enforceable requirements, as well as the District-only requirements. The District-only requirements are not a part of the Title V Operating Permits. The terms and conditions that are part of the facility's Title V permit are designated as "Federally Enforceable Through Title V Permit".

VIII. PERMIT REQUIREMENTS

The purpose of this evaluation is to review changes to federally enforceable requirements; therefore, this compliance section will only address rules that have been amended or added since the issuance of the initial Title V permit or most recent renewal of the Title V permit.

A. Fresno County Rule 110, Kern County Rule 111, Kings County Rule 111, Madera County Rule 113, Stanislaus County Rule 110, and Tulare County Rule 111 – <u>Equipment Breakdown</u>

In accordance with EPA's State Implementation Plan (SIP) Call, on February 17, 2002, the District rescinded Fresno County Rule 110, Kern County Rule 111, Kings County Rule 111, Madera County Rule 113, Stanislaus County Rule 110, and Tulare County Rule 111 from the San Joaquin Valley SIP.

Therefore, proposed conditions #1 and 2 on permit S-83-04 are no longer Federally Enforceable. Additionally, proposed condition #40 was modified to remove all references to County breakdown rules.

B. District Rule 2201 - New and Modified Stationary Source Review Rule (NSR)

District Rule 2201 has been amended since this facility's initial Title V permit was issued. However, the requirements of this rule are only triggered at the time the source undergoes a modification. All applicable requirements from any NSR permit actions have already been incorporated into the current Title V permit.

C. District Rule 2520 - Federally Mandated Operating Permits

No changes to this Rule have occurred since issuance of the previous TV permit; however, greenhouse gas emissions and applicant suggested changes to conditions referencing Section 9.3.2 will be addressed under Rule 2520 during this renewal.

Greenhouse Gas Discussion

There are no federally applicable Greenhouse Gas (GHG) requirements for this source. It should be noted that the Mandatory Greenhouse Gas Reporting rule (40 CFR Part 98) is not included in the definition of an applicable requirement within Title V (per 40 CFR 71.2). Therefore, there will be no further discussion of GHG in this evaluation.

Section 9.3.2 - Monitoring Requirements

Proposal:

The facility has proposed to modify the periodicity of true vapor pressure sampling and testing for existing floating roof tanks. Rule 4623 does not require periodic TVP and API testing for floating roof tanks, and Section 9.3.2 of Rule 2520 does not specify a periodicity for sampling, testing, or monitoring. The current condition proposed for revision reads as follows:

• Permittee shall conduct true vapor pressure (TVP) testing of the organic liquid stored in this tank at least once every ## months and/or whenever there is a change in the source or type of organic liquid stored in the tank. The TVP of any organic liquid shall be determined by measuring the Reid Vapor Pressure (RVP) using ASTM D 323 (Test Method for Vapor Pressure for Petroleum Products), and converting the RVP to TVP at the tank's maximum organic liquid storage temperature. The conversion of RVP to TVP shall be done in accordance with the procedures in appendix B of District Rule 4623. Records of TVP testing shall be maintained. [District Rule 2520, 9.3.2]

The condition above is included in the following floating roof tank permits:

Monitoring Requirement:

Where applicable requirements do not require periodic testing or instrumental or non-instrumental monitoring, periodic monitoring to yield reliable data for the relevant time period that are representative of the source's compliance with the permit, as reported pursuant to the requirements of section 9.5 of this rule. Such monitoring requirements shall assure use of terms, test methods, units, averaging periods, and other statistical conventions consistent with applicable requirement. Recordkeeping requirements may be sufficient to meet the requirements of this section.

Conclusion:

District Rule 4623 does not require periodic testing for floating roof tanks. Since there is no prohibitory rule requirement specifying TVP testing periodicity, the monitoring and true vapor pressure testing of floating roof tanks in accordance to Rule 2520 only needs to yield reliable data for a relevant time that demonstrates each floating roof each tank's compliance with the permit. The District has determined the minimum TVP testing needed to demonstrate compliance with the permit is test each time there is an organic liquid source or type change.

The following conditions will replace the condition mentioned above on each permit permit identified in the previous table.

- Permittee shall conduct true vapor pressure (TVP) testing of the organic liquid whenever there is a change in the source or type of organic liquid stored in this tank. The TVP of any organic liquid shall be determined by measuring the Reid Vapor Pressure (RVP) using ASTM D 323 (Test Method for Vapor Pressure for Petroleum Products), and converting the RVP to TVP at the tank's maximum organic liquid storage temperature. The conversion of RVP to TVP shall be done in accordance with the procedures in appendix B of District Rule 4623. Records of TVP testing shall be maintained. [District Rule 2520, 9.3.2]
- As used in this permit, the term "source or type" shall mean liquids with similar characteristics. The operator shall maintain records of API gravity of petroleum liquids stored in this unit to determine which are from a common source. [District Rule 2520, 9.3.2]

D. District Rule 4306 - Boilers, Steam Generators, and Process Heater - Phase 3

District Rule 4306 was amended on December 17, 2020. However, the amended rule is not SIP-approved by EPA. The previous version of this rule (amended October 16, 2008) is SIP-approved and was addressed by the District's previous permit renewal (S-1084572). Therefore, changes to the rule do not affect the current permit.

E. District Rule 4320 - <u>Advanced Emission Reduction Options for Boilers</u>, Steam Generators, and Process Heaters Greater Than 5.0 MMBTU/HR

District Rule 4320 was amended on December 17, 2020. However, the amended rule is not SIP-approved by EPA. The previous version of this rule (adopted October 16, 2008) is SIP-approved and was addressed by the

District's previous permit renewal (S-1084572). Therefore, changes to the rule do not affect the current permit.

F. District Rule 4702 - Internal Combustion Engines

District Rule 4702 was amended on August 19, 2021. However, the amended rule is not SIP-approved by EPA. The previous version of this rule (amended November 14, 2013) is SIP-approved and was addressed by the District's previous permit renewal (S-1160777). Therefore, changes to the rule do not affect the current permit.

G.40 CFR Part 60, Subpart Kb - <u>Standards of Performance for Volatile Organic Liquid Storage Vessels (Including Petroleum Liquid Storage Vessels) for Which Construction, Reconstruction, or Modification Commenced After July 23, 1984</u>

Except as provided in paragraph (b) of this subpart, the affected facility to which this subpart applies is each storage vessel with a capacity greater than or equal to 75 cubic meters (m³) that is used to store volatile organic liquids (VOL) for which construction, reconstruction, or modification is commenced after July 23, 1984. The floating roof petroleum storage tanks at this facility are subject to this subpart.

The January 19, 2021 amendment to section § 60.110b added the option to comply with 40 CFR Part 63, subpart WW as a method to satisfy the requirements of § 60.112b (Standard for Volatile Organic Compounds) and § 60.117b (Delegation of Authority). The new compliance option is not required, and the facility did not request to change compliance methods. Therefore, the latest changes to the rule do not affect the current permit.

H. 40 CFR 63 Subpart ZZZZ, <u>National Emission Standards for Hazardous Air Pollutants for Stationary Reciprocating Internal Combustion Engines (RICE)</u>

Subpart ZZZZ establishes national emission limitations and operating limitations for hazardous air pollutants (HAP) emitted from stationary reciprocating internal combustion engines (RICE) located at major and area sources of HAP emissions. This subpart also establishes requirements to demonstrate initial and continuous compliance with the emission limitations and operating limitations.

The amendments to this subpart include the streamlining of the existing fuel quality regulations in Section § 63.6604 and revisions to paragraphs (b) and (d) in Section § 63.6645. The amendments did not change the stringency of existing fuel quality standards and do not have any effect on

the current permit requirements. Therefore, this subpart will not be addressed further in this evaluation.

I. 40 CFR Part 64 - Compliance Assurance Monitoring(CAM)

40 CFR Part 64 requires Compliance Assurance Monitoring for units that meet the following three criteria:

- 1) the unit must have an emission limit for the pollutant;
- 2) the unit must have add-on controls for the pollutant; these are devices such as flue gas recirculation (FGR), baghouses, and catalytic oxidizers; and
- 3) the unit must have a pre-control potential to emit of greater than the major source thresholds.

a. S-83-1, -2, -3, -9, and -12 - Floating Roof Petroleum Storage Tanks

None of the tank units at this facility are subject to CAM, since they have no add on control devices.

b. <u>S-83-5 - 12.5 MMBtu/hr Natural Gas-Process Heater with Flue Gas Recirculation</u>

- 1) This process heater has emission limits for NOx, SOx, PM, CO, and VOC.
- 2) This process heater has an add-on control (FGR) for NOx emissions; therefore, it is potentially subject to CAM requirements for NOx.
- 3) The FGR System will be assumed to have a 70% NOx control efficiency.

Pre-Control PE:

Since the uncontrolled PE for Unit S-83-5 is less than 20,000 lb-NOx/yr (the Major Source threshold for NOx emissions), this unit is not subject to CAM for NOx emissions.

- c. <u>S-83-7 and -8 33.75 MMBtu/hr Natural Gas-fired Crude Oil Pipeline</u> Process Heaters
- 1) Each process heater has emission limits for NOx, SOx, PM, CO, and VOC.
- 2) Each process heater has an add-on control (FGR) for NOx emissions; therefore, each is potentially subject to CAM requirements for NOx.
- 3) The FGR System will be assumed to have a 70% control efficiency

Pre-Control PE:

Since the uncontrolled PE for Units S-83-7 and S-83-8 are each less than 20,000 lb-NOx/yr (the Major Source threshold for NOx emissions), therefore these units are not subject to CAM for NOx emissions.

IX. PERMIT SHIELD

A permit shield legally protects a facility from enforcement of the shielded regulations when a source is in compliance with the terms and conditions of the Title V permit. Compliance with the terms and conditions of the Operating Permit is considered compliance with all applicable requirements upon which those conditions are based, including those that have been subsumed.

A. Requirements Addressed by Model General Permit Templates

1. Model General Permit Template SJV-UM-0-3

By submitting Model General Permit Template SJV-UM-0-3 qualification form, the applicant has requested that a permit shield be granted for all the applicable requirements identified by the template. Therefore, the permit shields as granted in Model General Permit Template is included as conditions 38 and 39 of the facility-wide requirements (S-83-0-4).

X. CALIFORNIA ENVIRONMENTAL QUALITY ACT

The purpose of the Title V permit renewal is to update the permit to ensure that any changes to regulations since the issuance of the initial Title V permit or most recent renewal of the Title V permit are incorporated as permit requirements.

Per the California Environmental Quality Act (CEQA) Statute §21080.24, and CEQA Guidelines §15281, the issuance, modification, amendment, or renewal of any permit by an air pollution control district or air quality management district pursuant to Title V is exempt from CEQA, unless the issuance, modification, amendment, or renewal authorizes a physical or operational change to a source or facility. There will be no physical or operational change to the source or facility nor will the Title V permit renewal authorize a physical or operational change to the source or facility. Therefore, this project, a Title V permit renewal, is subject to a ministerial action that is exempt from CEQA.

Draft Renewed Title V Operating Permit

San Joaquin Valley Air Pollution Control District

EXPIRATION DA **FACILITY: S-83-0-4**

FACILITY-WIDE REQUIREMENTS

- 1. {118} No air contaminant shall be released into the atmosphere which causes a public nuisance. [District Rule 4102]
- 2. The owner or operator shall notify the District of any breakdown condition as soon as reasonably possible, but no later than one hour after its detection, unless the owner or operator demonstrates to the District's satisfaction that the longer reporting period was necessary. [District Rule 1100]
- The District shall be notified in writing within ten days following the correction of any breakdown condition. The breakdown notification shall include a description of the equipment malfunction or failure, the date and cause of the initial failure, the estimated emissions in excess of those allowed, and the methods utilized to restore normal operations. [District Rule 1100]
- {4364} The owner or operator of any stationary source operation that emits more than 25 tons per year of nitrogen oxides or reactive organic compounds, shall provide the District annually with a written statement in such form and at such time as the District prescribes, showing actual emissions of nitrogen oxides and reactive organic compounds from that source. [District Rule 1160, 5.0] Federally Enforceable Through Title V Permit
- {4365} Any person building, altering or replacing any operation, article, machine, equipment, or other contrivance, the use of which may cause the issuance of air contaminants or the use of which may eliminate, reduce, or control the issuance of air contaminants, shall first obtain an Authority to Construct (ATC) from the District unless exempted by District Rule 2020 (12/20/07). [District Rule 2010, 3.0 and 4.0; and 2020] Federally Enforceable Through Title V Permit
- {4366} The permittee must comply with all conditions of the permit including permit revisions originated by the District. All terms and conditions of a permit that are required pursuant to the Clean Air Act (CAA), including provisions to limit potential to emit, are enforceable by the EPA and Citizens under the CAA. Any permit noncompliance constitutes a violation of the CAA and the District Rules and Regulations, and is grounds for enforcement action, for permit termination, revocation, reopening and reissuance, or modification; or for denial of a permit renewal application. - 11. The cumulative length of all gaps between the tank shell and the primary seal greater than 1/2 inch shall not exceed 10% of the circumference of the tank. [District Rule 4623, 5.3.2.1.1 and 40 CFR 60.113b(b)(4)(i)] Federally Enforceable Through Title V Permit
- 12. The cumulative length of all primary seal gaps greater than 1/8 inch shall not exceed 30% of the circumference of the tank. [District Rule 4623, 5.3.2.1.1 and 40 CFR 60.113b(b)(4)(i)] Federally Enforceable Through Title V Permit
- 13. No continuous gap in the primary seal greater than 1/8 inch wide shall exceed 10% of the tank circumference. [District Rule 4623, 5.3.2.1.1 and 40 CFR 60.113b(b)(4)(i)] Federally Enforceable Through Title V Permit
- 14. No gap between the tank shell and the secondary seal shall exceed 1/2 inch. [District Rule 4623, 5.3.2.1.2, 6.1 and 40 CFR 60.113b(b)(4)(ii)(B)] Federally Enforceable Through Title V Permit
- 15. The cumulative length of all gaps between the tank shell and the secondary seal, greater than 1/8 inch shall not exceed 5% of the tank circumference. [District Rule 4623, 5.3.2.1.2 and 40 CFR 60.113b(b)(4)(ii)(B)] Federally Enforceable Through Title V Permit
- 16. The metallic shoe-type seal shall be installed so that one end of the shoe extends into the stored liquid and the other end extends a minimum vertical distance of 24 inches above the stored liquid surface. [District Rule 4623, 5.3.2.1.3 and 40 CFR 60.113b(b)(4)(i)(A)] Federally Enforceable Through Title V Permit
- 17. The geometry of the metallic-shoe type seal shall be such that the maximum gap between the shoe and the tank shell shall be no greater than 3 inches for a length of at least 18 inches in the vertical plane above the liquid. [District Rule 4623, 5.3.2.1.4] Federally Enforceable Through Title V Permit
- 18. There shall be no holes, tears, or openings in the secondary seal or in the primary seal envelope that surrounds the annular vapor space enclosed by the roof edge, seal fabric, and secondary seal. Except for gaps meeting permit requirements, the primary seal shall completely cover the annular space between the edge of the floating roof and tank wall. [District Rule 4623, 5.3.2.1.5; 40 CFR 60.112b(a)(2)(i)(A), 40 CFR 60.113b(b)(4)(i)(B) and 60.113b(b)(4)(ii)(C)] Federally Enforceable Through Title V Permit
- 19. The secondary seal shall allow easy insertion of probes of up to 1 1/2 inches in width in order to measure gaps in the primary seal. [District Rule 4623, 5.3.2.1.6] Federally Enforceable Through Title V Permit
- 20. The secondary seal shall extend from the roof to the tank shell and shall not be attached to the primary seal. Except for gaps meeting permit requirements, the secondary seal shall completely cover the annular space between the external floating roof and the wall of the storage vessel in a continuous fashion. [District Rule 4623, 5.3.2.1.7; 40 CFR 60.112b(a)(2)(i)(B) and 40 CFR 60.113b(b)(4)(ii)(A)] Federally Enforceable Through Title V Permit
- 21. All openings in the roof used for sampling and gauging, except pressure-vacuum valves which shall be set to within 10% of the maximum allowable working pressure of the roof, shall provide a projection below the liquid surface to prevent belching of liquid and to prevent entrained or formed organic vapor from escaping from the liquid contents of the tank and shall be equipped with a cover, seal or lid that shall be in a closed position at all times, with no visible gaps and be gas tight, except when the device or appurtenance is in use. [District Rule 4623, 5.2 & 5.5.1] Federally Enforceable Through Title V Permit
- 22. A gas-tight condition is defined as a condition without a gas leak. A gas leak is defined as a reading in excess of 10,000 ppmv, above background, as measured by a portable hydrocarbon detection instrument in accordance with the procedures specified in EPA Test Method 21. A reading in excess of 10,000 ppmv above background is a violation of this permit and Rule 4623 and shall be reported as a deviation. [District Rule 4623, 3.10 and 6.4.8] Federally Enforceable Through Title V Permit
- 23. Except for automatic bleeder vents, rim vents, and pressure relief vents, each opening in a non-contact external floating roof shall provide a projection below the liquid surface. [District Rule 4623, 5.5.2.2.1, and 40 CFR 60.112b(a)(2)(ii)] Federally Enforceable Through Title V Permit
- 24. Except for automatic bleeder vents and rim vents, roof drains, and leg sleeves, each opening in the roof shall be equipped with a gasketed cover, seal, or lid that shall be maintained in a closed position at all times (i.e., no visible gap) except when in actual use. [District Rule 4623, 5.5.2.2.2, and 40 CFR 60.112b(a)(2)(ii)] Federally Enforceable Through Title V Permit

- 25. Automatic bleeder vents shall be equipped with a gasket and shall be closed at all times when the roof is floating except when the roof is being floated off or is being landed on the roof leg supports. [District Rule 4623, 5.5.2.2.3, and 40 CFR 60.112b(a)(2)(ii)] Federally Enforceable Through Title V Permit
- 26. Rim vents shall be equipped with a gasket and shall be set to open when the roof is being floated off the roof leg supports or at the manufacturer's recommended setting. [District Rule 4623, 5.5.2.2.4, and 40 CFR 60.112b(a)(2)(ii)] Federally Enforceable Through Title V Permit
- 27. Each emergency roof drain shall be provided with a slotted membrane fabric cover that covers at least 90 percent of the area of the opening. The fabric cover must be impermeable if the liquid is drained into the contents of the tanks. [District Rule 4623, 5.5.2.2.5, and 40 CFR 60.112b(a)(2)(ii)] Federally Enforceable Through Title V Permit
- 28. External floating roof legs shall be equipped with vapor socks or vapor barriers in order to maintain a gas-tight condition so as to prevent VOC emissions from escaping through the roof leg opening. [District Rule 4623, 5.5.2.2.6] Federally Enforceable Through Title V Permit
- 29. All wells and similar fixed projections through the floating roof shall provide a projection below the liquid surface. [District Rule 4623, 5.5.2.3.1] Federally Enforceable Through Title V Permit
- 30. The solid guidepole well shall be equipped with a pole wiper and a gasketed cover, seal or lid which shall be in a closed position at all times (i.e., no visible gap) except when the well is in use. [District Rule 4623, 5.5.2.3.2] Federally Enforceable Through Title V Permit
- 31. The gap between the pole wiper and the solid guidepole shall be added to the gaps measured to determine compliance with the secondary seal requirement, and in no case shall exceed 1/2 inch. [District Rule 4623, 5.5.2.3.3] Federally Enforceable Through Title V Permit

The slotted guidepole well on a external floating roof shall be equipped with the following: a sliding cover, a well gasket, a pole sleeve, a pole wiper, and an internal float and float wiper designed to minimize the gap between the float and the well, and provided the gap shall not exceed 1/8 inch; or shall be equipped with a well gasket, a zero gap pole wiper seal and a pole sleeve that projects below the liquid surface. The permittee of external floating roof tanks shall make the primary seal envelope available for unobstructed inspection by the APCO on an annual basis at locations selected along its circumference at random by the APCO. If the APCO suspects a violation may exist the APCO may require such further unobstructed inspection of the primary seal as may be necessary to determine the seal condition for its entire circumference. - 36. If any source ceases to store volatile organic liquid for a period of 1 year or more, subsequent introduction of volatile organic liquid into the vessel shall be considered an initial fill. [40 CFR 60.113b(b)(1)(iii)] Federally Enforceable Through Title V Permit
- 37. The permittee shall inspect all floating roof tanks at least once every 12 months to determine compliance with the requirements of this rule. Actual gap measurements shall be performed when the liquid level is static but not more than 48 hours after the tank roof is re-floated. If the external floating roof has defects, the primary seal has holes, tears, or other openings in the seal or the seal fabric, or the secondary seal has holes, tears, or other openings in the seal or the seal fabric, the owner or operator shall repair the items as necessary before filling or refilling the storage vessel. The owner or operator shall notify the APCO in writing at least 30 days prior to the filling or refilling of each storage vessel to afford the APCO the opportunity to inspect the storage vessel prior to refilling. - 43. The owner or operator of each storage vessel shall keep readily accessible records showing the dimension of the storage vessel and an analysis showing the capacity of the storage vessel. - 44. Permittee shall maintain records of average daily throughput. [District Rule 2201 and District Rule 2520, 9.4.2] Federally Enforceable Through Title V Permit
- 45. Permittee shall maintain the records of the external floating roof landing activities that are performed pursuant to Rule 4623, Sections 5.3.1.3 and 5.4.3. The records shall include information on the true vapor pressure (TVP), API gravity, storage temperature, type of organic liquid stored in the tank, the purpose of landing the roof on its legs, the date of roof landing, duration the roof was on its legs, the level or height at which the tank roof was set to land on its legs, and the lowest liquid level in the tank. - 46. Permittee shall maintain a record of the liquid stored, the period of storage, and the maximum true vapor pressure of that liquid during the respective storage period. [District Rule 2201 and 40 CFR 60.116b(c)] Federally Enforceable Through Title V Permit
