Dear Ms. Thomas:

The Air Pollution Control Officer has issued Emission Reduction Credits (ERCs) to Consolidated Fiberglass for emission reductions generated by the shutdown of a fiberglass filament manufacturing facility, at 3747 Standard Street, Bakersfield, CA. The quantity of ERCs issued is 2,951 lb-NOx/yr, 7,429 lb-PM10/yr, 2,241 lb-CO/yr and 8,354 lb-VOC/yr.

UPF Corp has requested that the ERCs be issued to current owners Consolidated Fiberglass. As such, enclosed are the ERC Certificates issued to Consolidated Fiberglass and a copy of the notice of final action that has been posted on the District's website (www.valleyair.org).

Notice of the District's preliminary decision to issue the ERC Certificates was posted on February 14, 2022. The District's analysis of the proposal was also sent to CARB and US EPA Region IX on February 14, 2022. No comments were received following the District's preliminary decision on this project. However, a typographical error in the notice itself was corrected to match the evaluation. This change was minor and did not affect the basis for issuance of the above referenced ERCs.

Also enclosed is an invoice for the engineering evaluation fees pursuant to District Rule 3010. Please remit the amount owed, along with a copy of the attached invoice, within 60 days.
