#### I. PROPOSAL

SFPP, L.P. was issued their last Title V permit after it was renewed on May 25, 2016. As required by District Rule 2520, the applicant is requesting a permit renewal. Title 13 California Code of Regulations (CCR), Section 2423 – Exhaust Emission Standards and Test Procedures, Off-Road Compression-Ignition Engines and Equipment (Required by Title 17 CCR, Section 93115 for Emergency Diesel IC Engines)

The Air Toxic Control Measure (ATCM) is a rule under the California Code of Regulations (CCR) which is the official compilation and publication of the regulations adopted, amended or repealed by state agencies. The purpose of this rule is to reduce diesel particulate matter (PM) and criteria pollutant emissions from stationary diesel-fueled compression ignition engines.

## a) <u>C-1077-1-6 and -2-6: DIESEL-FIRED EMERGENCY STANDBY IC ENGINE POWERING A FIREWATER PUMP</u>

#### **VIII. PERMIT REQUIREMENTS**

The purpose of this evaluation is to review changes to federally enforceable requirements; therefore, this compliance section will only address rules that have been amended or added since the issuance of the initial Title V permit or most recent renewal of the Title V permit.

# A. Fresno County Rule 110, Kern County Rule 111, Kings County Rule 111, Madera County Rule 113, Stanislaus County Rule 110, and Tulare County Rule 111 – <u>Equipment Breakdown</u>

In accordance with EPA's State Implementation Plan (SIP) Call, on February 17, 2022, the District rescinded Fresno County Rule 110, Kern County Rule 111, Kings County Rule 111, Madera County Rule 113, Stanislaus County Rule 110, and Tulare County Rule 111 from the San Joaquin Valley SIP.

Since the facility is not located within Merced or San Joaquin County, it is not subject to the requirements of San Joaquin County Rule 110 or Merced County Rule 109 and the reference to these rules will be removed from conditions #1 and 2 on draft facility-wide permit C-3839-0. Therefore, proposed conditions #1 and 2 on draft facility-wide permit C-3839-0 are no longer Federally Enforceable due to the removal of all county rules as shown below.

{4362} The owner or operator shall notify the District of any breakdown condition as soon as reasonably possible, but no later than one hour after its detection, unless the owner or operator demonstrates to the District's satisfaction that the longer reporting period was necessary. [District Rule 1100, 6.1; County Rules 110 (Fresno, Stanislaus, San Joaquin); 109 (Merced); 113 (Madera); and 111 (Kern, Tulare, Kings)] Y

{4363} The District shall be notified in writing within ten days following the correction of any breakdown condition. The breakdown notification shall include a description of the equipment malfunction or failure, the date and cause of the initial failure, the estimated emissions in excess of those allowed, and the methods utilized to restore normal operations. [District Rule 1100, 7.0; County Rules 110 (Fresno, Stanislaus, San Joaquin); 109 (Merced); 113 (Madera); and 111 (Kern, Tulare, Kings)] Y

#### B. District Rule 2201 - New and Modified Stationary Source Review Rule

District Rule 2201 has been amended since this Title V permit was last renewed. However, the requirements of this rule are only triggered at the time the source undergoes a modification. All applicable requirements from any NSR permit actions have already been incorporated into the current Title V permit. The updated requirements of this rule are therefore not applicable at this time.

#### C. District Rule 2520 - Federally Mandated Operating Permits

This rule has been amended since this TV permit was last renewed, but the last amended version of the rule is not SIP approved. Additionally, the amendments to this rule do not have any effect on current permit requirements. However, only greenhouse gas emissions will be addressed under Rule 2520 during this renewal.

#### Greenhouse Gas Discussion

There are no federally applicable Greenhouse Gas (GHG) requirements for this source. It should be noted that the Mandatory Greenhouse Gas Reporting rule (40 CFR Part 98) is not included in the definition of an applicable requirement within Title V (per 40 CFR 71.2). Therefore, there will be no further discussion of GHG in this evaluation.

#### D. District Rule 4311, Flares (Amended December 17, 2020)

This rule limits VOC, NOx, and CO emissions from flares.

The rule was amended on December 17, 2020. The amended rule changed the definition of a "flare" to remove the exclusion that "flares" are not equipped with devices for fuel-air mix control or for temperature control. Therefore, due to this change, the vapor burner combustor listed under C-1077-3 is now subject to the requirements of this rule.

The requirements of this rule become effective on December 31, 2023. The facility is required to submit an Authority to Construct permit to comply with the future requirement by July 1, 2022.

#### E. District Rule 4601 - Architectural Coatings

This rule limits the emissions of VOCs from architectural coatings. It requires limiting the application of any architectural coating to no more than what is listed in the Tables 1 and 2 of Section 5.0 of the amended rule. This rule specifies architectural coatings storage, cleanup, and labeling requirements.

The rule was amended in April 16, 2020 but had not been SIP approved. The stringency analysis in Attachment D shows that the amended rule is as stringent as the SIP approved version of the rule that was adopted in December 17, 2009.

The following changes were included in the latest rule amendment that resulted in revising current permit requirements:

- The tables outlining the VOC content of different specialty coatings and colorants have been largely replaced with the Table 1 and Table 2 in Section 5.0.

The updated conditions 23, 24 and 25 on draft facility-wide permit C-1077-0 will assure compliance with the requirements of this rule.

#### F. District Rule 4702 – <u>Internal Combustion Engines</u>

The purpose of this rule is to limit the emissions of nitrogen oxides (NOx), carbon monoxide (CO), volatile organic compounds (VOC), particulate matter (PM), and sulfur oxides (SOx) from internal combustion engines. This rule applies to any internal combustion engine rated at 25 brake horsepower or greater. The permit units C-1077-1 and -2 are in compliance with the current SIP approved version of the rule. However, the last amended version of the rule, which is not SIP approved, requires lowering NOx and VOC emissions for spark-ignited IC engines, clarifying definitions, and updating test methods. Also the Particulate Matter Emission Control Requirements were added to the rule as Section 5.8, and as such, the purpose of the rule was amended to encompass the new requirements.

The engines listed under permits C-1077-1 and -2 are compression-ignited emergency standby engines equipped with a nonresettable elapsed time meter. Therefore, the amended sections of this rule are not applicable to these engines. Because the amendments to District Rule 4702 do not affect

the requirements for any permit unit at this site and no additional conditions are required, the changes will not be addressed any further in this evaluation.

- G. 40 CFR Part 60, Subpart K <u>Standards of Performance for Storage Vessels for Petroleum Liquids for Which Construction, Reconstruction, or Modification Commenced after June 11, 1973, and Prior to May 19, 1978</u>
- H. 40 CFR Part 60, Subpart Ka <u>Standards of Performance for Storage Vessels for Petroleum Liquids for Which Construction, Reconstruction, or Modification Commenced after May 18, 1978, and Prior to July 23, 1984</u>
- I. 40 CFR Part 60, Subpart Kb <u>Standards of Performance for Volatile Organic Liquid Storage Vessels (Including Petroleum Liquid Storage Vessels) for Which Construction, Reconstruction or Modification Commenced after July 23, 1984</u>

The current Title V permit for each of the organic liquid storage tanks contain the 40 CFR 60, Subpart K, Ka, and Kb requirements for external floating roof storage tanks or are exempt as they were constructed prior to June 11, 1973 and were never reconstructed or modified.

Subpart K and Subpart Ka have not been updated since the last Title V renewal action, so there are no changes to the existing permit conditions for permit units C-1077-6-, -8, -9, -10, -11, -12, -14, -15, -16, and -17. However, Subpart Kb was recently updated by the EPA to allow owners or operators of storage vessels subject to Subpart Kb, and equipped with either an external floating roof or an internal floating roof, the choice to elect to comply with the requirements specified in NESHAP Subpart WW as an alternative standard, in lieu of the requirements specified in NSPS Subpart Kb. SFPP, L.P. has applied, under project C-1220221, to modify their permits electing to comply with the alternative requirements in NESHAP Subpart WW. Therefore, the changes to Subpart Kb does not affect the existing Title V permits as the requirements of NESHAP Subpart WW will be incorporated in to the Title V permit through Authority to Construct permits and Title V Minor Modifications or Administrative Amendments.

# J. 40 CFR Part 63, Subpart BBBBBB – <u>National Emission Standards for Hazardous Air Pollutants for Source Category: Gasoline Distribution Bulk Terminals, Bulk Plants, and Pipeline Facilities</u>

#### §63.11080 The purpose of this subpart

§63.11080 states that this subpart established national emission limitations and management practices for Hazardous Air Pollutants (HAP) emitted from area source (not a major HAP source) gasoline distribution bulk terminals, bulk plants, and pipeline facilities. This subpart also established requirements to demonstrate compliance with the emission limitations and management practices.

#### §63.11081 Applicability of this subpart

§63.11081(a) states that the affected source to which this subpart applies is each area source bulk gasoline terminal, pipeline breakout station, pipeline pumping station, and bulk gasoline plant.

§63.11100 defines that a bulk gasoline terminal means any gasoline storage and distribution facility that receives gasoline by pipeline, ship or barge, or cargo tank and has a gasoline throughput of 20,000 gallons per day or greater.

The facility has a daily throughput greater than 20,000 gallons per day. Therefore, the requirements of this subpart apply to this facility.

#### §63.11082 Affected source covered by this subpart

§63.11082(a) states the emission sources to which this subpart applies are gasoline storage tanks, gasoline loading racks, vapor collection-equipped gasoline cargo tanks, and equipment components in vapor or liquid gasoline service that meet the criteria specified in Table 1 through 3 to this subpart.

This facility has the emissions units listed above, and therefore are required to comply with the applicable requirements of this subpart.

#### §63.11083 Compliance Date of this subpart

§63.11083(b) states an existing affected source must comply with the standards in this subpart no later than January 10, 2011. The compliance date has passed and continuous compliance with the requirements of this section is expected.

#### §63.11087 Gasoline Storage Tanks Requirements

§63.11087(a) requires each gasoline storage tank to meet the emissions limit and management practices in Table 1 to this subpart.

The capacity of each of the organic liquid (including gasoline) storage tanks listed under the following permits is greater than 75 m<sup>3</sup> (equivalent 19,813 gallons): C-1077-4, -5, -6, -7, -8, -9, -10, -11, -12, -13, -14, -15-, 16, -17, -18, -19, -20, -21, -22. Therefore, these storage tanks must meet the requirements listed under §63.11100, Table 1, item 2, as follows:

- a. reduce emissions of total organic HAP or TOC by 95% (by weight) with a closed vent system and control device; or
- b. equip each internal floating roof gasoline tank according to the requirements in 40 CFR Part 60 Subpart Kb, specifically, §60.112b(a)(1) except for the secondary seal requirement under §60.112b(a)(1)(ii)(B) and the requirements in §60.112b(a)(1)(iv) through (ix); and
- c. equip each external roof gasoline storage tank according to the requirements in §60.112b(a)(2), except that the requirements of §60.112b(a)(2)(ii) shall only be required if such storage tank does not currently meet the requirements of §60.112b(a)(2)(i); or
- d. equip and operate each internal and external floating roof gasoline storage tank according to the applicable requirements in §63.1063(a)(1) and (b), and equip each external floating roof gasoline storage tank according to the requirements of §63.1063(a)(2) if such storage tank does not currently meet the requirements of §63.1063(a)(1).

§63.11087(c) requires the owner or operator to perform testing and monitoring specified in §63.11092(e).

§63.11092(e) requires the owner or operator to perform inspections of internal floating roof gasoline storage tank per §60.113b(a).

§63.11087(d) requires the owner or operator to submit the applicable notifications as required under §63.11093.

§63.11093(a) requires the owner or operator to submit an Initial Notification as specified in §63.9(b). If the facility is in compliance with the requirements of this subpart at the time the Initial Notification is due, the Notification of Compliance Status required under paragraph (b) of this section may be submitted in lieu of the Initial Notification.

§63.11093(b) requires the owner or operator of an affected source under this subpart must submit a Notification of Compliance Status as specified in §63.9(b). The Notification of Compliance Status must specify which of the compliance options included in Table 1 of this subpart is used to comply with this subpart.

§63.11087(e) requires the owner or operator to keep records and submit reports as specified in §63.11094 and §63.11095.

§63.11094 and §63.11095 require to keep records and submit reports per §60.115b(a).

#### §63.11088 Gasoline Loading Rack Requirements

§63.11088(a) requires each loading rack to meet the emissions limit and management practices in Table 2 to this subpart.

The bulk gasoline terminal loading racks listed under permit C-1077-26, -27, -28, -29, -38, -42, and -51 are subject to this section.

#### §63.11089 Equipment Leak Inspections Requirements

§63.11089(a) requires the owner or operator to perform a monthly leak inspection of all equipment in gasoline service. For this inspection, detection methods incorporating sight, sound, and smell are acceptable.

§63.11089(b) requires that a log book must be used and must be signed by the owner or operator at the completion of each inspection. A section of the log book must contain a list, summary description, or diagram(s) showing the location of all equipment in gasoline service at the facility.

§63.11089(c) requires that each detection of a liquid or vapor leak must be recorded in the log book. When a leak is detected, an initial attempt at repair must be made as soon as practicable, but no later than 5 calendar days after the leak is detected. Repair or replacement of leaking equipment must be

completed within 15 days after detection of the leak, except as provided in §63.11089(d).

§63.11089(d) states that delay of repair of leaking equipment will be allowed if the repair is not feasible within 15 days. The owner or operator must submit a semiannual report that includes the reason(s) why the repair was not feasible and the date each repair was completed.

§63.11089(e) requires the owner or operator to comply with the requirements of this subpart by the applicable dates specified in §63.11083. §63.11089(f) requires the owner or operator must submit the applicable notifications as required under §63.11093.

As discussed in §63.11083(c), the facility is currently complying with the requirements of these sections.

§63.11089(g) requires the owner or operator to keep records and submit reports as specified in §63.11094 and §63.11095.

#### §63.11092 Testing and Monitoring Requirements

§63.11092(a)(1) requires the owner or operator to conduct a performance test on the vapor processing and collection system according to either paragraph (a)(1)(i) or paragraph (a)(1)(ii) of this section.

§63.11092(e)(1) requires the owner or operator operates gasoline storage tanks to perform inspections according to the requirement of §60.113b(a).

§63.11094(a) requires that all records be kept for at least five years. Therefore, the following condition will be included on the permit to ensure continuous compliance:

§63.11094(b) lists recordkeeping requirements for vapor tightness of trucks.

§63.11094(d) requires owners or operators that are subject to leak provisions, to keep a record describing the types, identification numbers, and locations of all equipment in gasoline service.

§63.11094(e) requires the owner or operator to keep records of equipment leak inspections.

#### §63.11095 Reporting Requirements

§63.11095(a)(1) requires the owner or operator to submit a semi-annual compliance report that includes information specified in §60.115(b)(a) for internal floating roof storage tank.

§63.11095(a)(2) requires the owner or operator to report each loading of a gasoline cargo tank for which vapor tightness document had not been previously obtained by the facility.

§63.11095(a)(3) requires the owner or operator to report the number of equipment leaks not repaired within 15 days after detection. However, District Rule 4624 requires leaks to be repaired with 72 hours.

§63.11095(a)(4) states the storage vessels complying with §63.11087(b) after January 10, 2011, the storage vessel's Notification of Compliance Status information can be included in the next semi-annual compliance report in lieu of filing a separate Notification of Compliance Status report under §63.11093.

§63.11095(b) requires the owner or operator of an affected source subject to the control requirements of this subpart to submit an excess emissions report to the Administrator at the time the semi-annual compliance report is submitted.

§63.11095(d) requires the owner or operator of an affected source under this subpart to submit a semi-annual report including the number, duration, and a brief description of each type of malfunction which occurred during the reporting period and which caused or may have caused any applicable emission limitation to be exceeded. The report must also include a description of actions taken by an owner or operator during a malfunction of an affected source to minimize emissions in accordance with §63.11085(a), including actions taken to correct a malfunction.

Compliance with the requirements of this rule is expected.

These units have no add-on controls; therefore, they are not subject to CAM.

#### b) C-1077-24

This unit has no emission limits listed on the permit; therefore, it is not subject to CAM.

#### c) <u>C-1077-3, -26, -27, -28, -29, -38, -42, -51,</u>

These units have an emissions limit, are served by an add-on control for VOC emissions, and have a pre-control potential to emit greater than the

major source threshold for VOC emissions. Therefore, CAM is applicable to these units.

Since all these units are served by a shared vapor burner combustion system listed under permit C-1077-3 as the control device, permit conditions to require monitoring to assure compliance for all these units will be listed under permit C-1077-3. As previously approved, a continuous temperature recorder is required to ensure a minimum temperature of 900 degrees F in the vapor combustion system listed under permit C-1077-3.

#### L. 40 CFR Part 82, Subpart B – Servicing of Motor Vehicle Air Conditioners

Per §82.30(b) these regulations apply to any person performing service on a motor vehicle for consideration when this service involves the refrigerant in the motor vehicle air conditioner.

#### M. 40 CFR Part 82, Subpart F – Recycling and Emissions Reductions

Per §82.150(a) the purpose of 40 CFR Part 82 Subpart F is to reduce emissions of class I and class II refrigerants and their substitutes to the

lowest achievable level by maximizing the recapture and recycling of such refrigerants during the service, maintenance, repair, and disposal of appliances and restricting the sale of refrigerants consisting in whole or in part of a class I and class II ODS in accordance with Title VI of the Clean Air Act.

Per §82.150(b) these regulations apply to any person servicing, maintaining, or repairing appliances. This subpart also applies to persons disposing of appliances, including small appliances and motor vehicle air conditioners. In addition, this subpart applies to refrigerant reclaimers, technician certifying programs, appliance owners and operators, manufacturers of appliances, manufacturers of recycling and recovery equipment, approved recycling and recovery equipment testing organizations, persons selling class I or class II refrigerants for sale, and persons purchasing class I or class II refrigerants.

The amendments to this subpart did not have any effect on the current permit requirements and will therefore not be addressed further in this evaluation.

#### IX. PERMIT SHIELD

A permit shield legally protects a facility from enforcement of the shielded regulations when a source is in compliance with the terms and conditions of the Title V permit. Compliance with the terms and conditions of the Operating Permit is considered compliance with all applicable requirements upon which those conditions are based, including those that have been subsumed.

#### A. Requirements Addressed by Model General Permit Templates

The applicant does not propose to use any model general permit templates.

#### B. Requirements not Addressed by Model General Permit Templates

The applicant is not requesting any permit shields.

#### C. Obsolete Permit Shields From Existing Permit Requirements

There are few county rules have been removed from the San Joaquin Valley SIP as discussed in Section VII.A and also the facility is not subject to the other county rules; therefore, the permit shield for all county rules will be removed from condition 39 on draft facility-wide permit C-1077-0.

39. {4400} Compliance with permit conditions in the Title V permit shall be deemed in compliance with the following outdated SIP requirements: Rule 401 (Madera, Fresno, Kern, Kings, San Joaquin, Stanislaus, Tulare and Merced), Rule 110 (Fresno, Stanislaus, San Joaquin), Rule 109 (Merced), Rule 113 (Madera), Rule 111 (Kern, Tulare, Kings), and Rule 202 (Fresno, Kern, Tulare, Kings, Madera, Stanislaus, Merced, San Joaquin). #### X. CALIFORNIA ENVIRONMENTAL QUALITY ACT

The purpose of the Title V permit renewal is to update the permit to ensure that any changes to regulations since the issuance of the initial Title V permit or most recent renewal of the Title V permit are incorporated as permit requirements.

Per the California Environmental Quality Act (CEQA) Statute §21080.24, and CEQA Guidelines §15281, the issuance, modification, amendment, or renewal of any permit by an air pollution control district or air quality management district pursuant to Title V is exempt from CEQA, unless the issuance, modification, amendment, or renewal authorizes a physical or operational change to a source or facility. There will be no physical or operational change to the source or facility nor will the Title V permit renewal authorize a physical or operational change to the source or facility. Therefore, this project, a Title V permit renewal, is subject to a ministerial action that is exempt from CEQA.

## **Public Comments / District Responses**

Public comments regarding the preliminary decision SFPP, L.P.'s Title V permit renewal are provided below followed by the District's responses.

### SFPP, L.P. Comment #1:

An application has been submitted to incorporate NESHAP Subpart WW for the internal floating roof tanks. Is it possible to incorporate the WW alternative compliance requirements in the renewed Title V permit?

### <u>District Response to SFPP, L.P. Comment #1:</u>

The District has received your Authority to Construct application to incorporate the NESHAP requirements of Subpart WW and has begun processing the request under Project C-1220221. In order to streamline the Title V renewal and not duplicate any work already performed under project C-1220221, the Title V renewal project will not be modified to include the requirements of Subpart WW. The requirements of Subpart WW can be incorporated in to the Title V permit through a Title V Minor Modification. Additionally, the discussion of 40 CFR 60 Subpart within this evaluation

### SFPP, L.P. Comment #2:

Rule 4623 citations (Sections 5.3.1.3 and 5.3.2) for internal floating roof tanks included on the permit are for external floating roof tanks.

#### **District Response to SFPP, L.P. Comment #2:**

Section 5.3.1.3 of Rule 4623 specifies the landing requirement for floating roofs that is under the section entitled "Specifications for External Floating Roof Tanks", but is also applicable to internal floating roof tanks as required under Section 5.4.3. Therefore, the references to Section 5.3.1.3 will remain on the permits for the floating roof tanks.

Section 5.3.2 of Rule 4623 specifies the criteria for seal designs for floating roofs, also under the section entitled "Specifications for External Floating Roof Tanks". The provisions of Section 5.3.2 are required of internal floating roof tanks as specified in Section 5.4.1 with the exception of complying with the requirements specified in Section 5.3.2.1.3. Section 5.3.2.1.3 requires the seals to be installed so that one end of the shoe extends into the stored liquid and the other end extends a minimum vertical distance of 24 inches above the stored liquid surface; however, Section 5.4.1 only requires a minimum vertical distance of 18 inches above the surface of the liquid surface. Therefore, the following conditions on the draft permits were updated with changes reflected on the final permits:
