The LPG tank is permit exempt under Rule 2020 (Exemptions) Section 6.6.9. It is estimated that approximately 2-3 bodies per month or 40 per year will be cremated at the facility. The quantity of human remains cremated will not exceed 480 lbs per day or 43,200 lbs per year. Any crematory facility under 300 bodies per year is exempt from the Air Toxics Program. This facility is estimated to have emissions under the 2lbs per day (less than the BACT threshold) for each criteria pollutant.

1. Prioritization:

A prioritization score will be determined for the HAPs prior to emissions modeling. No further evaluation is needed if the resulting prioritization score is less than 1.0.

2. Screening HRA:

The screening model used by Technical Services is the Environmental Protection Agency's (EPA's) *Screen3*. *Screen3* is capable of modeling point, area, volume, and flare sources. Using either an array or discrete receptor distances, the *Screen3* model can determine emittent concentration at any user-specified distance. Worst case meteorological data is used in the concentration calculation.

3. Refined HRA:

A refined HRA is required when the screening HRA evaluation acute or chronic indices exceed one and/or the screening HRA cancer risk exceeds one in a million (1.0×10^6).

Analysis

Prioritization

Technical Services performed an initial prioritization using parameters provided by the processing engineer listed in Table 1 below. The prioritization score was 2.35 at a receptor distance of 18.29 meters. This was greater than the trigger limit of one. A screening analysis was required.

*Higher concentrations were found at 48 meters. This distance was subsequently used for modeling purposes. The actual concentration found at the nearest school was used in the school cancer risk analysis minus the risk contributed by garden.

Screening HRA Results

The EPA's *Screen3* model was used to determine the maximum concentration dispersion value. This value was then input into the HRA96 model to calculate the chronic and acute hazard indices and the carcinogenic risk factor for the project.

CONCLUSION:

The chronic and acute indices are below one (1) and the cancer risk factor associated with the LPG-fired crematory incinerator is less than one (1) in a million. Therefore, in accordance with the District's Risk Management Policy, permitting may proceed without consideration of Toxic Best Available Control Technology (T-BACT).
