4. PUBLIC COMMENTS – None.

- CHAIR COMMENTS Ms. Kelly-Ortega said she was looking forward to Mr. McVaigh's updates.
- 6. <u>APCO/DEPUTY APCO COMMENTS</u> Mr. McVaigh said the Governing Board adopted the District's annual budget in May, including the incentive spending plan. He said Mr. DeYoung will provide details of the spending plan next month.

Mr. McVaigh said there was a presentation on form-based coding at the Governing Board study session. He said the District is interested in form-based coding because it has the potential to promote multiple-use planning, which would reduce traffic and vehicle miles travelled. The Governing Board authorized up to \$10,000 in next year's budget to host an educational forum on air-friendly land uses, including form-based coding. Staff is working on ideas for this forum.

Mr. Smith said street design and transportation systems tie into form-based coding. He suggested the Model Street Design Manual for Livable Streets as a topic to include in the educational forum. This manual serves as a template to assist in achieving balanced street design that accommodates cars while ensuring that pedestrians, cyclists and transit users can travel safely and comfortably.

Mr. McVaigh said the Governing Board has expressed interest in enhancing the Burn Cleaner incentive program and the District would like input from EJAG. Mr. Williams drafted an initial proposal for the Grants Committee. Once approved by EJAG, the final recommendation will go to the CAC and the Governing Board.

7. <u>RULE AND 2012 PM2.5 PLAN UPDATES</u> – Jessi Fierro, Strategies and Incentives Manager and Legal Specialist, presented the updates.

Ms. Ruiz asked about the feedback received for Rule 9610. Ms. Fierro said there was a comment period associated with the workshop and there is an open comment period based on the proposed rule. She said the District received comments from the EPA and many comments regarding clarification on the

enforceability components of the rule. Ms. Fierro said all comments and responses are summarized in the staff report available on the District's website.

(Note: It was subsequently determined that the June 19 date will not work due to lack of availability of CAC members.)

8. <u>EJ DISTRICT MAP OVERLAY</u>- Samir Sheikh, Strategies and Incentives Director, presented an overlay of the District's EJ map as compared to the top 20 percent of vulnerable communities according to CalEPA's EnviroScreen. The maps largely overlap, but some of EnviroScreen's vulnerable communities are not included in the District's EJ map, and the District's map includes a few areas not included in EnviroScreen.

Mr. Sheikh asked for input on how to use EnviroScreen to assist with the District's ongoing EJ efforts. He said this tool may help in identifying some EJ communities not captured in the District's map. He asked EJAG if they wanted to review the maps to look at areas for potential inclusion, and if they wanted to reform the maps subcommittee. Mr. Sheikh added the District would also like input on how best to use this tool in making a strong case for bringing more state funding to the Valley.

Mr. Williams asked if EnviroScreen's top 20 percent includes bigger cities, such as Visalia, because some areas of bigger cities should be excluded. Mr. McVaigh said the District EJ map includes the north part of Visalia and a small part of Tulare, but EnviroScreen includes those entire cities. He said the District

map was done by census tract of about 10,000 people and EnviroScreen used zip codes. Neither method eliminated those areas entirely. Mr. Sheikh said OEHHA continues to enhance their tool and plans to do a census tract level. He said although this won't fully resolve the issue, it will provide more resolution. Mr. Smith mentioned the great deal of variation found in cities throughout the Valley.

Ms. Celedón-Castro asked how the District EJ map compares to the top 10 percent of EnviroScreen. Mr. Sheikh said the top 10 percent of EnviroScreen still represents about 60 percent of the Valley. Ms. Celedón-Castro said the entire Valley is affected by air pollution, but the intent of the EJ map is to focus on communities that are affected the most. She suggested focusing on the top 10 percent or 5 percent and creating EJ priority areas or "red zones." Mr. Williams suggested creating a tiered program.

<u>Public Comment:</u> Byanka Santoyo, Arvin Bucket Brigade coordinator, said she came to the meeting in hopes of gaining support for her organization's efforts. Ms. Kelly-Ortega asked Ms. Santoyo to stay for the general public comment period and provide more information.

Mr. Fox asked about the small EJ communities not identified by EnviroScreen. Mr. McVaigh said some EJ communities may be only a small part of a census tract or zip code and therefore were not captured by EnviroScreen. Mr. Fox suggested getting information on small communities from other agencies, such as the Department of Agriculture.

9. GRANTS COMMITTEE RECOMMENDATION UPDATES— Mr. Williams said he drafted an initial proposal regarding the Burn Clean incentive program. The Grants Committee will finalize the recommendation in June and present it to EJAG for approval. It will then be presented to CAC and the Governing Board in August.

Ms. Kelly-Ortega said she can no longer be on the Grants Committee. Ms. Garcia will take her place.

14. <u>PUBLIC COMMENTS (Second Opportunity)</u> – Ms. Santoyo said the Arvin Bucket Brigade wants EJAG to know about their concerns and to show support for their efforts.

Ms. Garcia asked for background information about the organization and its objectives. Ms. Santoyo said she is contracted with Global Community Monitoring (GCM), an environmental justice and human rights non-profit that empowers industrial communities to re-create a clean, healthy and sustainable environment. GCM has developed the use of "bucket brigades" as a method for communities to collect valid scientific data and document impacts of pollution.

Ms. Santoyo said the bucket brigade tests for volatile organic compounds (VOCs) at facilities in Arvin. They are working on identifying major contributors. Ms. Santoyo said the Arvin Bucket Brigade is hoping to gain support from other agencies and organizations.

Mr. Fox asked about the Pep Boys lawn mower program he mentioned at the April meeting. Ms. Heinks told Mr. Fox the District is not affiliated with the Pep Boys program, but the District's new lawn mower program starts on June 4.

Mr. Fox expressed concerns about Valley Fever. Ms. Kelly-Ortega told Mr. Fox the presentation on Valley Fever will be next month, and she will forward his comments to Dr. Lighthall.
