- 4. PUBLIC COMMENTS None.
- CHAIR COMMENTS Mr. Williams announced that Ms. Garcia is resigning from EJAG. The recruitment process will begin soon for a new at-large representative for Madera County.
- 6. <u>APCO/DEPUTY APCO COMMENTS</u> Mr. McVaigh said there were several items of interest on the agenda for the November Governing Board Meeting.

Mr. McVaigh said District staff will make a presentation on a potential approach to assess wood smoke impact in foothill communities. If wood smoke is found to be a public health issue in these communities, the District would initially look into a voluntary program with outreach and education and potentially additional incentives.

Mr. McVaigh said at the beginning of the fiscal year, the District allocated \$8 million to replace/retrofit school buses. At the Governing Board Meeting, the District will propose leveraging an additional \$3 million from the Public Benefit Grants program for replacing school buses. With this program, school districts can receive up to 50 percent in matching funds to replace some of their oldest buses.

Mr. McVaigh announced the summer ozone season ends October 31st and for the first time in history, the Valley had no exceedences of the 1-hour ozone standard. The District will formally ask the EPA to deem the Valley in attainment and to lift the Clean Air Act penalties.

- 7. <u>RULE AND 2012 PM2.5 PLAN UPDATES</u> Errol Villegas, Strategies and Incentives Manager, presented the update.
- 8. REVIEW OF DISTRICT OUTREACH MATERIALS Jaime Holt, Chief Communications Officer, said the District is working on a new brochure for the Healthy Air Living (HAL) program. The purpose of this brochure is to communicate what the program is and to encourage people to get involved. She asked EJAG to look over the provided information and offer their feedback. Ms. Holt said the District is also working on revamping the HAL website and is looking for ideas there as well. Mr. Williams asked everyone to bring their ideas to the December meeting.

9. <u>TRUCK GRANT PROGRAM (OVERVIEW)</u> – Todd DeYoung, Strategies and Incentives Program Manager, made the presentation.

Ms. Mares-Alatorre asked about the District's outreach strategy. Ms. Holt said the District has done radio spots and has placed bilingual posters at truck stops, truck washes and convenience stores. Ms. Mares-Alatorre suggested doing outreach at trucking schools. Ms. Kelly-Ortega suggested truck weighing stations and highway billboards. Ms. Holt said the District spoke with CalTrans about using highway billboards, but it wasn't an option.

Mr. Dean asked if it was possible to get a list of truck owners from the DMV in order to send out information. Mr. DeYoung said the ARB has access to DMV data and the truckers database. Mr. McVaigh added that the ARB included flyers in registration renewal notices.

Mr. Williams stressed the importance of outreach and ensuring all truckers are aware of the new regulations. If truckers aren't aware of the regulations and their trucks are not in compliance, these trucks will be taken off the road, which will make prices go up. This will have an impact on EJAG communities. If this happens, Mr. Williams said he would recommend the District request an extension from the ARB.

<u>Public Comment</u>: Naazim Hamed, President of San Joaquin Valley Minority Contractors Association, thanked Mr. Dean for inviting him to attend the meeting. Mr. Hamed said many members of his organization need this grant program. He said his organization's outreach program can work with the District to help get the information out.

Mr. Williams suggested having the presentation in February because of other critical items on the December agenda.

Mr. Dean said he was approached by Dennis Fox who felt he wasn't given adequate opportunity to speak at the last meeting. Mr. McVaigh said there is opportunity for public comment at the beginning and ending of every meeting. These opportunities are for comments regarding items that are not on the agenda. There is also opportunity for public comment on each agenda item.

Mr. Williams added the Brown Act requires all action items be open to public comment. Generally, every item is opened up for public comment, but occasionally when there is a very full agenda, discussion items maybe not be opened for public comment.
