- 3. <u>Approve Minutes of April 23, 2015</u> The Chair asked if there were any comments regarding the Minutes for April 23, 2015. Having decided the Minutes were accurate, on motion of Mr. Dean and seconded by Mr. Lemen, unanimously passed, the Minutes were approved with no changes.
- 4. Public Comments None
- Chair Comments Mr. Williams expressed appreciation for the opportunity to serve as EJAG Chair. He also acknowledged the newest EJAG member, Thomas Helme.
- 6. <u>APCO/Deputy APCO Comments</u> Samir Sheikh, Deputy APCO, congratulated the members of EJAG for a well-attended meeting. He reported the Board approved the new reporting structure for EJAG who will now report directly to the Governing Board. Mr. Sheikh provided a summary of items discussed at the May Governing Board Study Session. He reported the Board approved \$4 million for the Tune In Tune Up program and \$750,000 for the Restaurant Charbroiler Technology Partnership at the June meeting.

Mr. Dean asked the frequency EJAG will be reporting to the Board and how the information will be generated. Mr. Sheikh explained the approved direction was for EJAG to report to the Board as needed and that EJAG will continue to provide reports to the CAC, for a trial period of one year. He added District staff will prepare a summary report similar to that prepared for the CAC which will be available for an EJAG representative to use during their presentation to the Board.

Mr. Dean asked what incentive there is for developers to enter into voluntary emission reduction agreements with the District to mitigate emissions from development projects. Mr. Sheikh responded that the District's ability and expertise in achieving quantifiable and certifiable emissions reductions assists developers seeking to mitigate emissions impacts from their projects.

Mr. Hamilton and Mr. Campos asked for more information regarding the Hot Spot based strategy. Mr. Sheikh briefly explained the complexities of the issue and reported that the District is in the beginning stages of exploring this strategy per Governing Board direction.

Mr. Hamilton requested a status on the promotion of natural gas as a potential clean air freight technology. Mr. Sheikh reported that the Board approved an action plan for promoting the deployment of natural gas vehicles and infrastructure in the San Joaquin Valley.

Mr. Hamilton asked for more information regarding the District's drought relief efforts. Mr. Sheikh provided a quick overview of drought relief measures including a new advisory to implement changes to the District's enforcement policies regarding water-dependent dust control requirements in recognition of the need for reasonable actions to help avert the public health crisis faced by Valley residents and communities experiencing shortages of drinkable water.

Mr. Campos suggested the District wait on approving VERAs until after the permitting process has been completed and the lead agency has approved the project. He asked if the District can regulate dust emissions coming from agricultural fields in preparation of planting crops. Mr. Sheikh explained that the District's Conservation Management Practices rule regulates fugitive particulate emissions from agricultural land preparation.

7. <u>Updates on Attainment Plans and Rules</u> – Sheraz Gill, Director of Strategy & Incentives, presented the updates.

Mr. Dean asked for the proposed meeting schedule for the Public Engagement Initiative for the Development of the Ozone Plan workgroup. Mr. Sheikh responded that the process is expected to begin soon but that there is no set schedule at this time. Mr. Dean asked for the status of the Air Shed Grant application. Mr. Sheikh stated the application has been submitted with the support of EJAG. Mr. Dean requested more information regarding the retirement of over-polluting vehicles including the previous suggestion of enhancing the local program. Mr. Sheikh explained the state-run program for retiring vehicles has been integrated into what is done at the local level. Mr. Hamilton also expressed interest in learning more about the programs to retire vehicles. Mr. Sheikh explained the local program Tune In Tune Up now includes a new replacement component and expressed appreciation for EJAG's support in developing the new program and securing state funding.

Mr. Hamilton suggested providing assistance to small businesses that may need to meet any new charbroiling requirements.

Mr. Campos asked what rules are being considered in the development of the plan for the 2006 PM2.5 standard. Mr. Gill responded the plan is in its beginning stages and there will be several opportunities for public participation.

8. Appoint Chair (2-Year Term) and Vice-Chair (1-Year Term) –

Motion passed to elect Esperanza Vielma as Chair (2-Year Term) and Derek Williams as Vice-Chair (1-Year Term).

9. Valley Efforts Related to Cap and Trade Funds – Tom Jordan, Senior Policy Advisor, provided detailed information on the comprehensive action plan approved by the Governing Board at the May Study Session for ensuring that the San Joaquin Valley receives its fair share of Cap and Trade funding. Mr. Jordan provided a summary of the action plan, which includes educating state policy makers about the Valley's tremendous needs, building a San Joaquin Valley Cap and Trade Coalition to advocate on behalf of the Valley, utilizing the District's expertise and infrastructure to administer Cap and Trade funded grant programs, and pursuing a block grant approach to establish dedicated Cap and Trade funding for the San Joaquin Valley. Mr. Jordan also provided a summary of potential funding opportunities at various state agencies and encouraged EJAG members to share the information with their constituencies.

Mr. Jordan additionally discussed the significant barriers experienced by Valley entities in applying for funding provided by the Strategic Growth Council for affordable housing and transportation projects, particularly with respect to the unavailability of tools for quantifying the greenhouse gas and other benefits of potential projects. EJAG member Cesar Campos discussed the difficulties that he has seen with this issue and suggested that enhanced tools be developed to assist Valley entities in preparing more competitive grant proposals.

EJAG members emphasized the importance of advocating for the Valley's fair share of funding, and several members expressed interest in participating in the San Joaquin Valley Cap and Trade Coalition. EJAG members unanimously supported the Board's action plan for securing the Valley's fair share of Cap and Trade funds and several members expressed interest in participating in the San Joaquin Valley Cap and Trade Coalition. Additionally, EJAG members unanimously supported that the District pursue the development of enhanced tools for quantifying the benefits of Valley projects.
