By attending these meetings, Committee members ensure that Valley cities maintain a strong voice on the District's Governing Board. He said last year Committee members voted to have city representatives including Councilmember Bomprezzi, Councilmember Baines, and Councilmember Hanson serve a longer term on the Board because their three-year terms made it difficult to grasp the complexity of the Valley's air quality issues. Tonight's appointment of Mayor Brazil to a three- year term will complete that cycle and

then in the next two years the Committee will reconvene to begin the process of selecting new city representation on the Board.

Mr. Sadredin expressed his gratitude to Mayor Brazil for once again volunteering to serve on the Board to deal with difficult air quality issues and for being generous in his compliments when things are done well but holding feet to the fire to make sure they are done right. He said Mayor Brazil has been a strong advocate for good government and also set a good example among other Board members that a healthy economy and environment are not mutually exclusive and there is a good balance that can be achieved by working with the business community and public to ensure that the strong measures in place are still affordable for Valley businesses.
