Don't trash our air

For many years, burning trash in a barrel in the back yard was a common practice. What better way to destroy financial information or classified documents? However, garbage often contains plastics, metals and synthetic materials that create dangerous emissions when burned.

The San Joaquin Valley already fails to meet clean- air standards for particulate matter and ozone pollution. Both of these pollutants are a by-product that is either created directly or indirectly by burning such materials.

In 1992, the Air District adopted rule 4103, Open burning, which makes burning the following items illegal within Air District boundaries:

- Household garbage
- Shrubbery, lawn clippings, rose prunings and weeds
- Vegetable garden residue and orchard prunings
- · Lumber, plywood, particle board and other wood products
- Painted or stained wood
- Christmas trees
- Demolition debris or construction and roofing materials
- Furniture and mattresses
- · Tires and other plastic or rubber products
- Paints, solvents and their containers
- Petroleum products such as waste oil, gas and diesel
- Electric wire or metal for salvage
- Animal carcasses, manure, hay and bedding
- Vegetation transported from one property to another
- Anything processed, manufactured or treated

Dispose of Waste Properly

To avoid penalties, citations and fines, the Air District encourages you to properly dispose of these materials through a waste collection service or at an approved waste disposal facility. Hazardous wastes, including solvents oil and paints, must be taken to a local hazardous waste collection site.

Many materials may be reused or recycled. Unwanted clothing, furniture, toys and books can be donated to a charity, friends, schools or other organizations. Take recyclable items to a recycling center or waste collection site.
